## DEMAND FOR AN ANNUAL LOCAL CONTRIBUTION

Local Financial Year commencing on the 1st day of January, 2008.

WHEREAS by certificate dated the20 <sup>th</sup> day ofMay 2008, the
Minister for Education and Science has authorised the
County Dublin Vocational Education Committee(a)
to demand from theSouth Dublin County Council(b)
being the rating authority for the vocational education area of the said committee an
annual local contribution for or in respect of the said local financial year of the
amount ofOne Hundred and Sixty Four Thousand Three Hundred
Euro (€164,300.00) NOW the County Dublin Vocational
Education Committee(a) in pursuance of subsection (2) of section 46 of
the Vocational Education Act, 1930, (No. 29 of 1930) hereby demands that the
South Dublin County Council
(b)
shall pay to the said Committee as an annual local contribution in respect of the said
local financial year the said sum ofOne Hundred and Sixty Four Thousand
Three Hundred Euro(€ 164,300.00 ) by transferring the said sum to the credit
of the account of the said Committee in the Allied Irish Bank, 7-12 Dame Street,
Dublin 2(c) being the Treasurer of the said Committee, in four equal
instalments, the first whereof shall be so transferred not later than the 15th day of
February, 20, the second not

Later than the 1<sup>st</sup> day of April, 2008, the third not later than the 1<sup>st</sup> day of July, 2008, and the fourth not later than the 1<sup>st</sup> day of October, 2008.
