# Graffiti- Applications

- Scheme A-four applications for the RAPID areas of West Tallaght (€90,000) and North Clondalkin (€30,000). Funding held by Pobal and to be spent by the end of 2008
- Scheme B- one application of €147,903 for West Tallaght, East Tallaght & Whitechurch areas

## Graffiti- Phase 2

- **Grant available is €50,000-€150,000**
- **Graffiti removal (Compulsory) €50,000 max**
- **Graffiti Reduction Measures:**
  - **Improved design of existing streetscape/landscape. €15,000 max**
  - **Targeted Initiatives €30,000 max**
  - **Training Initiatives €40,000 max**
  - **Educational Initiatives €30,000 max**
  - **Supporting Businesses €15,000 max**
  - **Community Arts Projects €20,000 max**
