

Introduction

The European Water Framework Water Framework Directive (WFD) 2000/60/EC came into force in 2000 and required each Member State to transpose it into domestic legislation. In Ireland it was enacted through the European Communities (Water Policy) Regulations 2003 (SI 722 of 2003) which has since been amended in 2005 and 2008. The full text of the Statutory Instrument can be found at www.wfdireland.ie.

Eight River Basin Districts were established in the island of Ireland based on natural catchment geography. The Eastern River Basin District included the 4 principal catchments:

- Boyne
- Liffey
- Nanny/Delvin
- Vartry/Avoca.

Each of these catchments includes other minor catchments as well as lakes and estuaries (transitional waters). In addition, all coastal and groundwaters within the District fall within the objectives of the Directive; these waters can cross catchment and District boundaries.

The work of the Eastern River Basin District (ERBD) was led by Dublin City Council, as coordinating authority, supported by their consultant CDM.

This document outlines the key requirements of each article of the WFD, those in the Irish Statute SI 722 and how each of these has been fully addressed.

Water Framework Directive *Article 1*: Purpose - establish a framework for the protection of all WFD designated water bodies

Comment: Local Authorities acting jointly in the ERBD are establishing environmental objectives, programmes of measures and Advisory Councils and are making the necessary River Basin Management Plans. Public Authorities take measures appropriate to their function to promote/achieve implementation of the Directive/Regulations and encourage the active involvement of all interested parties. The Minister and EPA provide co-ordination and guidance at national level which is provided for within the established WFD framework.

Comment: A review of the Monitoring Programme will commence imminently by EPA as required by the Directive. In addition to reviewing the Monitoring Site locations, the EPA is also reviewing the water body split (especially where the water body is a long river stretch) in order to most effectively capture the cause/effect relationship and provide for the establishment of more cost effective.

Comment: The GIGS meetings at EU level which are attended by EPA personnel continue to inform the Reference Conditions and Classification designations.

Comments: The Programme of Measures takes into account the parallel processes of Strategic Environmental Assessment and Appropriate Assessment (Habitats Directive) and addresses any Mitigation Measures arising from these necessary parallel statutory processes. A Draft Environmental Statement will issue with the Final Programme of Measures for adoption.

River Basin Management Plans to be made by the 12 no. If the deadline is not achieved the making of the Plan shall cease to be a reserved function and shall become an executive function exercisable by the managers of the relevant authorities.

The Draft River Basin Management Plan was completed by December 2008. A revised River Basin Management Plan is now emerging following the 6 month Public Consultation with all the bona fide submissions being addressed and a separate Submissions Report being prepared. The Final Plan will be the subject of briefings to all the ERBD constituent Local Authorities in September 2009 and will go forward for vote as stipulated. The Plan was supported by detailed PowerPoint presentations on the web site for each sub catchment or water body in the District

The local authorities have been given access to a web based River Basin Management System designed to help them work through the WFD process for all waters in their jurisdiction.

Related Activities

Many Local Authorities have more than one RBD in their jurisdictional area and accordingly it would be ideal to have harmony both in terms of Plan content and in terms of procedure for adoption. In many instances the Local Authorities are also producing their own Local Authority Plan as an extract from each of the relevant RBD Plans that coincide with the jurisdictional area.

Comment: The anomalies arising in Ireland as a result of our Local Government system and lack of tradition in relation to catchment management focus has been a constant difficulty notwithstanding the very good cooperation from all involved in cooperating at RBD level. There are no National Water Authorities or River Basin District Authorities in Ireland and accordingly no management structure or management control system with budget.
