**Lucan Area Committee Meeting of South Dublin County Council
held on 23rd November 2010**

Dear Mr. Doherty,

At the meeting of the Lucan Committee held on the 23rd November 2010 the following emergency motion was passed by the Members of the Area Committee:

“That this Committee requests the Manager to write to Dublin Bus as a matter of great urgency to express the concerns on the introduction of the new Network Direct Bus Schedules that had the effect of causing:

- Unprecedented queuing delays for many residents in Lucan and Palmerstown areas that caused serious inconvenience.***
- Great stress to local residents in Foxborough as a result of early and unacceptable noise levels at the new bus terminus in Foxborough estate given the close proximity to local residents' homes and longer delays for local residents in Foxborough in exiting the estate at morning peak times owing to increased traffic congestion at this new bus terminus.***

Further that Dublin Bus would reply to this area committee immediately and set out clearly its response to remedy these matters.”


Dear Ms. Colgan,
