Following a claim on the bond earlier this year and subsequent discussions with bondholder, Newlyn Developments returned to site in Oct 2011 and minor landscaping works have been completed. The remaining item at this point is ponding on part of a roadway and submission of documentation awaited for transfer of deed of dedication for open space. As soon as ponding is resolved and deed is approved the advertisement of T.I.C will take place.

Following discussions with the bondholder and the Council, the developer has since returned to the site and completed the remaining surface works. CCTV and as constructed drawings submitted were inaccurate however when reviewed and SDCC has requested new ones from developer to enable conclusion of inspection of services. ### E ESTATES WHERE INSPECTIONS OF WORKS ARE IN PROGRESS:

577 St. Edmunds Lucan Glenkerrin

Mixed development under construction. Management Agreement submitted. The full development is not completed, only approximately 30-40% of the permission has been carried out with the remaining site secured and sectioned off. The Council is liaising with recently appointed receivers to determine the condition of the areas to be completed to a taking in charge standard and the receiver is arranging engagement of consultant engineers to work with the Council in this matter.

Mixed residential development. Consultations have occurred with developer regarding taking in charge and Council are awaiting imminent submission of taking in charge package from developer.

### F1 ESTATES SUBJECT TO LEGAL DIFFICULTIES:

235 Larkfield Lucan Fitzgibbon Bros

Following discussions with the bondholder, the developer returned to site and completed minor works and submitted CCTV surveys. The Council has reviewed the CCTV and the underground services have been approved. The significant issues at present are wayleaves for the Council to access services in both a square area to the front of the development operated by a management company and gaining access to a public lighting standard and underground services resulting from the enclosure of such services in areas enclosed by boundary walls of residents properties. Legal solutions for this are currently being investigated but if the Council cannot access services it will be a barrier to taking in charge.

### F2 ESTATES SUBJECT TO ENFORCEMENT ACTION:

108 Rossberry Lucan Kingscroft Ltd & Hollioake Ltd

Two developers built Rossberry, Kingscroft and Hollioake.

The Council is claiming security lodged for completion of remedial works to part of the development carried out by Hollioake and is preparing an advert recommending the taking in charge of the development for publication by end december 2011, thereafter completing the works using sequestered security.

In respect of the part developed by Kingscroft, there remain significant issues affecting public lighting. It may be necessary to utilise enforcement powers to resolve this matter.

### G ESTATES UNDER CONSTRUCTION:

64 Tullyhall (Phase 3) Lucan Eleveden
Properties Ltd

Part Under construction - Less than 15 units built only. Works have ceased on this site at present however the remaining site is secured. An extension of duration for the permission has been granted and security remains in place in relation to the permission.

#### J ESTATES WHERE BOND IS BEING CLAIMED

224 Hansted Lucan McInerney
Construction

Despite initial favourable indication about completion of works, due to lack of response the Council placed claim on bond in Oct 2011 No reply from bondholder or receiver since this.

The Council therefore is enforcing the relevant conditions pertaining to public services and serving a notice in this regard.

It is also likely that it will be necessary to consult the Councils legal advisors on next steps in the bond claim given the failure of the bondholder to engage since the end of October.
