Apartments and duplexes are private and under Management Company. Drainage not to be taken in charge -roads, footpaths, public lighting for taking in charge. Meeting July 2011 clarified surface works required, however CCTV and as constructed drawings have not been received which prevents establishing full scale of work and bond is therefore being

retained.
