REPLY

I propose to take questions 9, 29, 30, 33, 63, 66 and 67 together.

I am very aware of the cases to which the Deputy refers and my officials monitor these and other cases very closely.

The first individual referred to has been detained since 13 May 2011, following the revocation of her life licence by the Secretary of State for Northern Ireland. Genuine concerns have repeatedly been raised about several aspects of this case by deputies on many occasions, and I have raised them very frankly with the British Government most recently when I met the Secretary of State for Northern Ireland last Monday 11 February. I have been advised that the Parole Commissioners will determine on the issue of her continued detention in March.

In relation to the second individual referred to, the British authorities have confirmed that he was released under licence in 1992. The Secretary of State for Northern Ireland revoked that licence in April 2010 and the individual has as a result been in custody for the past 2 years and 9 months. I understand that an appeal in relation to the case will be heard by the Supreme Court in Belfast shortly. As the case is the subject of an ongoing legal process, it would be inappropriate to comment further at this time.
