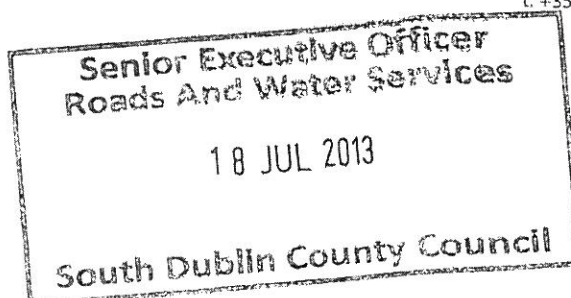

Dear Mr. Curtin

I refer to your letter of 20 June 2013 regarding the provision of an additional Post Office in the Lucan area.

The Company expects to advertise the contract to operate the new post office by the end of this week. Advertisements will be placed on the Company website and also in a number of post offices in the Lucan/Clondalkin area. Candidates will be invited to submit applications to the Dublin Regional Office and such applications must include details of the premises at which it is proposed to operate the new post office.

The Regional Office Management will assess the applications, interview the candidates and visit and assess the suitability of proposed premises as appropriate, before making recommendations to the Company Selection Board.

As in all cases, the Selection Board will then choose what it believes to be the best overall proposal, based on a number of criteria e.g. the location of the premises, the overall suitability of the premises, relevant experience and suitability of the candidates etc., assuming at least one of the proposals is deemed to be suitable. The Contract will then be offered to the best candidate subject to normal terms and conditions.

It is expected that the process should be concluded in approximately three months, unless there are any unforeseen problems.
