At the meeting of the Clondalkin Area Committee held on the 19th February 2014 the following motion was passed by the Members:

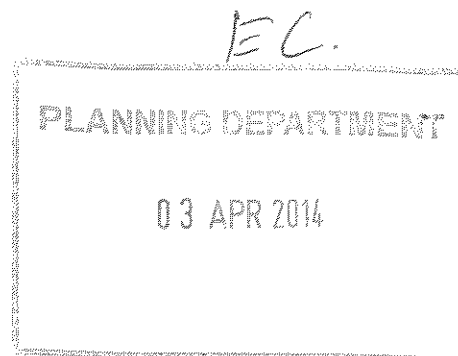
