Social Housing Investment Programme, 2014.

Dear Director,

The purpose of this letter is to advise you of 2014 funding allocations in respect of the following programmes:

- (1) Energy Efficiency Insulation (2nd Tranche) and
- (2) Improving Social Housing Stock – Once Off Adaption Works.

Please be aware that this funding is conditional on all projects being completed and claims being forwarded to this Department before Friday **14 November 2014**. This Department will NOT reimburse LAs for any works invoiced after this date and the funding will be redirected.

Energy Efficiency Insulation

Circular Letter Housing 9/2014 which issued in February 2014, informed local authorities of their initial allocation for 2014 under the Energy Efficiency measure. The Department committed to making a further allocation to local authorities mid-year on the basis of the progress achieved in implementing the Phase 1 works (wall insulation and attic insulation), which were targeted at the improvement of insulation standards and overall energy performance across 30,000 social rented properties. The 2nd tranche of allocations for Phase 1 works (only) is set out in **Appendix A**.

Once-off Adaptation Works

Allocations are provided in **Appendix B** to cover works in respect of extensions and adaptations for persons with a disability. The maximum funding in any individual case may not exceed €75,000. A contribution of 10% will be required from the authority's own resources.
