Re: 2014 Local Property Tax (LPT) Statistics – Preliminary June 2014

I am directed by the Minister for the Environment, Community and Local Government to refer to 2014 Local Property Tax (LPT) preliminary statistics provided to this Department by the Revenue Commissioners.

- 2014 LPT Exempt (additional to declared liabilities)

This 2014 data represents the best currently available information to estimate pre variation LPT levels for 2015 and does not include any household charge income collected. This is of course subject to normal fluctuations that may be caused by transfers in property ownership and the on-going compliance campaign in operation by the Revenue Commissioners.
