Land Use Planning & Transportation

Objective 1: Implement an Annual Road Works Programme of maintenance and improvements

The following roadworks have been completed:- New Road Clondalkin, Kennelsfort Rd. Upper, Harelawn Park Peamount Cross /Newcastle Main St., Station Road/Crag Ave. St. Marks Ave., Palmerstown Main St., Hermitage Road Ballydowd Grove, Balgaddy Road, Dodder Park Road, Lower Dodder Road, Grange Road/Taylors Lane, Hilltop Lane, Tibradden Road, Oldbawn Road, Belgard Road Phase 1, Cruagh Road. Roadworks are underway in:-Dunawley, Oakwood, Outer Ring Road Roundabout- Lynches Lane, Lyons Road, Roundabout: Liffey Valley Industrial Estate/Cold cut Road, Tubber Lane, Knocklyon Road, Scholarstown Road, Ballymount Road Lower, Cherryfield Estate, Seskin View Road, Conors Lane, Cullens Lane, Cunard, Newtown Lane, O' Rourke's Lane, Castlekelly, Sloggers Lane. Footpath repair works have been completed in:- Kennelsfort Road, Beechpark, Harelawn, Oakwood Grove, Woodford Downs/Heights, Cloverhill Road, Shancastle Lawns, Esker Drive, Esker Park, Esker Glebe, Palmerstown Drive, Ballydowd, Westbrook Park, Dodder Park Road, Lower Dodder Road, Grange Road/Taylors Lane, Hilltop Lane, Tibradden Road, Oldbawn Road, Belgard Road Phase 1, Cruagh Road. Footpath repairs works are underway in:- St. John's Park East, St Mark's Gardens, Glenfield, Greenfort, Whitethorn, Ballycullen Drive, Ballycullen Avenue, Ballyroan Park, Butterfield Avenue, Anne Devlin Park/Road/Drive Whitecliffe, Fernwood/Mountdown, Muckross Ave., Dangan/Shelton/Rockfield.

Objective 2: Maintain a professional planning and development management structure and processes

Works on the new Clonburris SDZ Planning Scheme is continuing. It is anticipated that the Statutory Public Consultation process will commence in October. Members will be briefed on the main aspects of the scheme prior to the Draft Scheme being published. The Planning Department is also progressing work on assessing lands /sites for the Vacant Site levy which will come into effect in January 2017. Discussions are also on going with various landowners/housing developers regarding the recent Local Infrastructure Housing Activation fund (LIHAF). Proposals to access the fund have to be submitted to the Department in Mid October.

Objective 3: Promote all modes of transport including walking and cycling to improve the movement of people within and beyond the county

Works have been completed on a section of the Tallaght to Ballyboden Cycle Scheme at the junction of Knocklyon Road and Idrone at Supervalue. Works are Continuing on Willsbrook Phase 3 Junction Improvement in Lucan. Construction work is approaching completion on the new junction of Ballymount Road Lower and Ballymount Avenue in Ballymount Industrial Estate. Works have also commenced on the Grange Road Plaza at St Endas as part of the 1916 Commemoration Projects.

Objective 4: Invest in Sustainable Communities and Quality of Life Initiatives

The Statutory Public Consultation process on the proposed new 30kph residential speed limit has commenced and submissions invited from the Public. The Bew Bye-laws, once adopted, will see speed limits in all housing developments reduced from 50kph to 30kph. Works are underway to the Rathfarnham Gateway Project at the northern end of Rathfarnham village and will be complete by Mid October. Plans for an upgrade to the Belgard Walkway (adjacent to McDonalds) have been agreed with the Area Committee. In addition plans for village enhancement works at the Texaco Garage in Newcastle and Saggart Village are also at an advance stage of design.

Housing, Social & Community Development

Objective 1 : Put in place a three year programme to supply social housing in the context of the Social Housing Strategy 2020

Council has continued to work with the Department in progressing the housing projects to tender stage. Suncroft Tallaght -10 dwellings to be completed October 2016 while St Finians - 2 Dwellings is completed as is Belgard Road Tallaght - 3 Dwellings. Focus on delivery on 105 Rapid Delivery Units with a further 100 required during 2017. Stage 3 approval received for Mayfield Clondalkin and MacUilliam .Three projects for Aged Friendly step down units at appropriate locations being progressed. This will be an opportunity for tenants that are living alone in larger two storey units to be in a dedicated supported environment close to many facilities and services. 1,083 active accounts on HAP at 12th September 2016. PPP for 100 Units as part of bundle of 500 units being progressed. Location at Grange Clondalkin. An integrated housing proposal for The Grange is being finalised and Clondalkin members will be briefed on the proposal. New CAS Call received with ring fenced funding for congregated settings and second one for Homeless, elderly and vulnerable.15 Applications received providing 18 Units. 401 on Homeless Register at end of August 2016 (193 families and 215 single males/females). 601 presentations during May 2016 (464 repeats). 16 Homeless Allocations made during May. 9 units for homeless women and children at Cuan Alainn reopened. Housing Needs Assessment is underway and completed return by 14/10/16.All those on housing list at 21/9/2015 being assessed.

Objective 2: Take a leadership role in social inclusion and interagency co-operation

Rural LEADER 'LAG' (Local Action Group) established comprising the Fingal LCDC and representatives from SDCC and DRL LCDC - Local Development Strategy (LDS) for the Dublin Rural Area approved by the Department. Calls for expression of interest on DRL website. The Healthy County Strategy Group is promoting Physical activity and leading actions from the National Physical Activity Plan on an interagency basis. Quit Campaign for Women run successfully with 12 completing the course and 7 ceasing smoking. Great interest in the 2nd course to start in next couple of weeks. Sponsored by the Healthy County committee and is facilitated at Fettercairn. Decision on accreditation as Healthy County anticipated by end of September 2016.

Objective 3: Promote health, wellbeing, recreation and activity to improve quality of life

Health and Wellbeing Week 2016 launched by the Mayor in the presence of Minister Katherine Zappone on Monday 12th September 2016 at Tallaght Stadium. Full week of free events with closing ceremony at Corkagh Park on Sunday 18th September 2016 with a family activity day. Summer Projects with Council support - 26 projects at a contribution of €32,500 supporting approx 6,000 participants. Bainisteoir 1 is a new App developed through collaboration with St Patricks GAA Club member and support from SDCC which guides parents and coaches for Under 12 kids through basics of Hurling and Football. Filmed with Dublin stars the App now fully developed and available since beginning of May has 1080 Twitter followers & 4,000 app downloads. Official launch is being arranged. The installation of Smoke Alarms and Carbon Monoxide Alarms and Fire Blankets is underway. Recently produced "trusted tradespeople" booklet for Newcastle. This is a pilot project with the RAMs group in Newcastle. Tenders received for anti-snap locks doors and patios for old aged and vulnerable to be evaluated. For installation by year end.

Objective 4: Facilitate community leadership and development through community engagement and empowerment

The 2016 Community Initiative Fund announced in June 2016. The announcement of the successful 18 applicants' notified and official ceremony being arranged. SPORTIVATE 2016 completed with 5 participants receiving full

awards. The recruitment for the 2016/2017 course is almost complete. Council supported the Pride of Place Entrants 2016 with 5 entrants. SDCC submitted Glenasmole Community Association, RAMS, Re-Create, St Dominick's CC and SDCC PPN. Judging carried out over 3 days at end of August 2016. 9 Tidy Towns Groups Active as of start of the year and 2 new groups' identified and capacity building work has commenced. Both successful in gaining CIF funding in 2015. A number of requests have also been received for groups expressing an interest to become involved in the Tidy Towns Programme that will be further examined and staff will work with to assess and assist the group's capacities. PPN signing of MOU with CE and Mayor held on 17th August 2016.New PPN Member Directory Launched and Training Programme announced. Also new South Dublin County Community Voice Online Facebook Forum.

Environment, Water & Climate Change

Objective 1: Improve the appearance of our county in the interest of economic development

Litter Management Plan: 2016 LM Action Plan has been agreed and Q3 Action Plan updates are currently being presented to each Area Committee. Actions include an increased visibility of the Litter Warden Service and more targeted and coordinated patrols in villages, towns and at known litter /dumping locations. Enforcement and Licensing: Programmable Audio Messaging Devices currently being installed at 8 locations across the County to deter litter/illegal dumping, dog fouling and graffiti. N81 Improvement Scheme: Meeting held with Austen Associates on 6.9.2016 to review revisions to concept design. Part VIII plans being prepared for pre-consultation presentation to the Rathfarnham Templeogue - Terenure and Tallaght ACMs in October. Roundabout Sponsorship: Designs are being prepared for 2 roundabouts in Ballymount Industrial Estate at present for which sponsorship agreements with Noyeks are committed. Design being finalised for roundabout at Orwell/Wellington Lane. Design for Roadstone roundabout on ORR has been approved. The upgrading of Scholarstown/ Templeroan roundabout will be completed by end September. Tree Maintenance Programme: 2016 Tree Maintenance Programme is ongoing. Two tree crews are in operation with works ongoing at Birchview, Kilnamanagh and at Liffey Estate. Derelict Sites: 14 Sites on Derelict Sites Register, with 3 derelict sites being acquired compulsorily & 1 by agreement. It is expected that additional acquisitions will take place. Road Sweeping Contract: The Council's road sweeping contract with Oxigen Environmental expires on 31 March 2017. The process to procure a new service has commenced, Expressions of Interest were invited in mid-August with a closing date of September 22nd.

South Dublin has been selected along with Kildare and Limerick in a STRIVE small scale noise research project over the next two months. Comparisons and contrasts will be made between Ireland the Netherlands on the whole field of noise complaints relating to traffic.
