## December Council Management Report

Update On Annual Service Plan This report includes the strategy updates for the month of Dec 2017

### Corporate Performance and Change Management

Objective 1: Support local democracy including the policy making and representation role of our Elected Members

• At the Council meeting held on the 12/12/2016 a presentation on Collaborative Budgeting was given and following the selection process the Lucan EA was selected. The proposed variation of the Ballycullen Oldcourt Local Area plan was also heard. • The review of standing orders for Area Committees is ongoing. Copies of standing orders for 9 other LAs with 40 or more members have been received and an analysis of the data received will take place in early January as part of the review process. • Work is ongoing on the 2017 Register of Electors. A meeting was held with Dublin City Council and Dun Laoghaire Rathdown County Council to view the back office development of Voter.ie and consider timelines for implementation in South Dublin in 2017. • The Mayor's Events Programme including the Mayor attending official Christmas Tree Lighting Ceremonies at County Hall, Tallaght and Civic Offices Clondalkin.

Objective 2: Provide robust financial management, risk management, audit and corporate governance systems

• Finance Management: The Councils three year Capital Programme for the years 2017 - 2019 was noted by the members of South Dublin County Council at the Councils monthly meeting on Monday the 12th December. The three year Capital Programme provides details of the expected €286m to be invested providing new and improved infrastructure & facilities to the Citizens of South County Dublin. Councils Rates section continues to liaise with the Valuation Office regarding the revaluation of South Dublin County Council in 2017. Council has also received the sanction of the Department for Housing, Planning, Community and Local Government to an overdraft accommodation in the sum of €25m for the financial year 2017, in line with member's approval given at the December monthly meeting of the Council. • Audit: The Audit Committee met on 13th December and reviewed their performance during 2016. The committee also agreed their work programme for 2017 and reviewed their charter, both of which will be circulated to the January Council meeting. The committee also approved the internal audit plan for 2017. • The Draft Data Retention and Archiving Policy has been prepared and is currently being review and edited. • Procurement: The review of The Council's usage of available OGP contracts has commenced. The Procurement Officer attended the Dublin Region Procurement Officers meeting on 13th December. Managing tender processes, provision of internal advice service and the review of internal communications material is ongoing. • Six Sigma: 6 Yellow belt projects were presented and approved by the Lean Six Sigma Steering group at a meeting held on 2nd December. The Project timescales are Jan-Mar 2017. • The Ethics Registrar was appointed with effect from 1st December 2016 for a two year period. • The public register was updated on the Council website in accordance with the requirements of the 2015 Lobbying Act. • A plan for the tendering of contracts relating to the Corporate Buildings in 2017 is being collated.

# Economic, Enterprise and Tourism Development

Objective 1: Maintain a supportive business environment with job creation and retention at its heart

Evaluation and Approvals Committee Meeting was held on 6th December 2016, approving 3 projects, creating 1.5 new jobs, with grant amounts of €46,494 approved. Total amount approved, €583,250 for 35 projects creating 42 new jobs. The next meeting is scheduled for February 2017. The Business Support Funds scheme is being promoted on the LEO Website, Council website, through social media and through SD Chamber. Shop Fronts: 16 applications received and Letters of Offers issued. 8 applicants' submitted quotations, 4 of these have confirmed completion of works & payment approved. 1005 applications received for Business Support Grant to date in 2016.

# Housing, Social & Community Development

Objective 1 : Put in place a three year programme to supply social housing in the context of the Social Housing Strategy 2020

Council has continued to work with the Department in progressing the housing projects to tender stage. Focus on delivery on over 200 Rapid Delivery Units during 2017 as outlined in report to September 2016 Council Meeting. St Marks Green and Mayfield Estate Fortunestown and Dromcarra Tenders are in. Stage 3 approval received from the Department early December to proceed to tender on Letts Field, Ballyboden and Killinarden projects. Total units being progressed through these projects is 176. RAPID Build projects Part 8 process for Old Bawn Mill Site and St Cuthberts underway. Tender notice issued in respect of St Aidans. Completed 65 acquisitions in 2016 excl. CAS units. Proposal / brief progressing on Kilcarbery Integrated Housing Project. PIN issued in December 2016. PPP for 100 Units as part of national bundle of 500 units being progressed at this location also. 1,403 active accounts on HAP at 19th December 2016. 449 on Homeless Register at end of November2016 (243 single males/females). 649 presentation during November which is down from 715 presentations during October 2016 (Average of 36 per day).

### Objective 2: Take a leadership role in social inclusion and interagency co-operation

Review of the Local Economic and Community Plan has started and consultation sessions held through PPN. The PPN consultations on LECP were held as follows: Consultation: Environment, Education and Training Date: Wednesday 9th November 2016 Consultation: Health, Wellbeing, Poverty and Social Inclusion Date: Thursday 10th November 2016 PPN Plenary + Citizenship and Participation Consultation as follows: Date: Tuesday 22nd November 2016 Work on finalising the Joint Policing Plan for the SDCC JPC continues. For approval in 1st Quarter 2017. New Drugs Awareness subcommittee set up under auspices of JPC.

Objective 3: Promote health, wellbeing, recreation and activity to improve quality of life

The Healthy County Strategy Group is promoting Physical activity and leading actions from the National Physical Activity Plan on an interagency basis. Quit Campaign for Women run successfully with 12 completing the course and 7 ceasing smoking. 2nd course is underway with larger numbers participating.. Sponsored by the Healthy County committee and is facilitated at Fettercairn Community Centre. Provider for anti-snap locks doors and patios continues installation in suitable homes. With approx. 500 for installation by early January. 700 applications were received funding for the 2017 scheme provided for in Budget 2017 and will be rolled out mid-2017. National Sports Policy Framework Public Consultation Paper Launched Nov 2016. Referred to SPC members for Discussion and input and Local Sports Partnership. Operation Transformation which will hit the TV screens again at the start of January with one of the leaders (Sean Daly) coming from Clondalkin. Groups around the county will be looking to promote community fitness and wellbeing and the programme offers a great opportunity for sports clubs, schools and community groups to foster closer community involvement, and with it more direct support for your activities. SDCSP and South Dublin County Council are once again supporting groups to get involved by offering; FREE volunteer walk leader training (2.5 hrs), FREE PR materials (banners/posters), FREE nutrition talks FREE equipment (weighing scales) for those who wish to offer a weight loss measurement to their programme. Tallaght Team won the Dublin Region senior final of the Late Nite Leagues at Irishtown on 9th December 2016. The Late Nite Leagues is a joint initiative of the FAI, Gardai and Local Authorities to help combat Anti Social Behaviour. SDCC had 4 team qualifying for the finals following our own finals at Greenhills Astro Park on 3rd December 2016.

Objective 4: Facilitate community leadership and development through community engagement and empowerment

PPN membership/registration now stands at 433 at end of December 2016 and communications to other groups is being broadened. To assist in this the new Directory has been launched and Training Programme announced. The SDCC Endeavour Awards and Community Initiative Fund 2016 will be evaluated and reported to the Social and Community SPC prior to embarking on the 2017 Programmes.

Objective 1: Implement an Annual Road Works Programme of maintenance and improvements

Road resurfacing on the R148 in Palmerstown commenced in December, but was temporarily suspended for Operation Open City and will recommence in January when works will be undertaken at night time. The Roadworks programme for 2016 is complete and the 2017 Programme is currently being prepared.

### Objective 2: Maintain a professional planning and development management structure and processes

Construction and Planning activity is progressing on Adamstown SDZ. Currently 177 homes are under construction and a planning application for a further 267 units has been lodged with the Planning Section. Preplanning work is also progressing on a further block in the Somerton Development Area. Planning permission has also been granted for the Community /Sports Hall adjacent to the existing Secondary School. Overall in 2017 over 800 planning applications will have been received, which is a c8% increase on 2015. In addition over 220 pre-planning enquires will have dealt with in the year. The Vacant Site levy will come into effect in January 2017. Approximately 120 sites have been identified as potential candidates, i.e. that meet the criteria set out in the Urban Regeneration and Housing Act 2015. Initial contact will be made with the relevant landowners during January advising them that their lands may be entered on the Vacant Site register in 2017. The proposed amendment to the Ballycullen - Oldcourt Local Area Plan went on public display and the closing date for submissions is 9th February 2017.

Objective 3: Promote all modes of transport including walking and cycling to improve the movement of people within and beyond the county

Works are Continuing on Willsbrook Phase 3 Junction Improvement in Lucan. Work on upgrading the Pedestrian Crossing on the N81 at the Avonmore Road junction is also complete. The new traffic signals at the junction of Ballymount Road Lower and Ballymount Avenue in Ballymount Industrial Estate came into operation in mid-January. Works are also progressing on the Grange Road Plaza at St Endas and the Ballyroan Green Schools Cluster project.

### Objective 4 : Invest in Sustainable Communities and Quality of Life Initiatives

The deadline for submissions under the Statutory Public Consultation process on the proposed new 30kph residential speed limit has passed and submissions are now being compiled and considered by the Traffic Section. The Bew Bye-laws, once adopted, will see speed limits in all housing developments reduced from 50kph to 30kph. A report on the Public Consultation process has been brought to the Area Committees in December and a final decision made by Full Council in January 2017. Works are complete to the Rathfarnham Gateway Project at the northern end of Rathfarnham village. Tender Documents are being prepared for village enhancement works at the Texaco Garage / Newcastle Lyons roundabout in Newcastle. Works on the Belgard Walkway in Tallaght are due to commence construction in Mid January and the walkway will be closed to the public for the duration of the project.

# Environment, Water & Climate Change

### Objective 1: Improve the appearance of our county in the interest of economic development

Litter Management Plan: Implementation of the 2016 Litter Management Action Plan continues and actions for 2017 are currently being considered. Actions include an increased visibility of the Litter Warden Service, targeted and coordinated patrols in villages /towns, relocation of programmable audio devises to deter litter/illegal dumping, dog fouling, examination of locations / consideration of additional CCTV, litter bin review, development of advertisements and promotional material. Seasonal Campaigns - Christmas recycle campaign was advertised in local newspapers and on social media. Dedicated Christmas page is on the SDCC site for the duration of the Christmas period. N81 Improvement Scheme: The preliminary design for the N81 improvement scheme progressed in 2016. The Part 8 commenced in November 2016 with the closing date for receipt of submissions on January 20th, 2017. It is intended to complete the Part 8 process early in 2017 and, subject to acceptance, a budgetary allowance has been made for the project progression in 2017 and 2018. Roundabout Sponsorship: Arrangements being made for improvement works to be carried out on roundabout in Ballymount Industrial Estate at junction Ballymount Road/Turnpike Road to enable sponsorship agreement to be finalised with Noyeks. Draft sponsorship agreement document is prepared for approval prior to issue. Roundabout Meeting with WORK RA took place in November where agreement was reached regarding SDCC proposed upgrade of Orwell roundabout. Sponsorship arrangements being pursued in respect of tender proposals for roundabouts at Ballyboden Road/Taylors Lane and at Scholarstown/Templeroan. New enquiry received expressing sponsorship interest in two roundabouts on Nangor Road - both require improvement works in

advance of a sponsorship arrangement being put in place for 2017. Tree Maintenance Programme: 2016 Tree Maintenance Programme is ongoing. Two tree crews are in operation. Sean Walsh Park crew are currently working on a programme of tree removals and pruning at Elmcastle estate. This crew will progress to commence tree maintenance works at Templeogue Woods during week beginning November 21. The tree crew operating North of N7 are currently working on a programme of tree pruning and removals at Cappaghmore estate. Planting of first 300 trees is now complete by contract, total 426 trees planted to date in 2016. Total of 3,729 tree inspections in period Jan to October, 1168 trees pruned in the same period and 554 trees removed. Road-sweeping Contract: Village maintenance crews have now been deployed in Tallaght, Saggart, Clondalkin and Lucan. Objective 2: Incorporate environmental sustainability in all policy-making and implementation programmes

Flood Alleviation Schemes: Ballycullen stream Tenders 8 No. are currently with consultant for tender assessment, recommendation expected shortly. SDCC/DCC have finalised the brief for Poddle scheme and agreed it with the OPW. DCC have a dedicated member of staff working on the framework and are due to have documents ready to go to tender in December. Surface Water Schemes: Surveying work completed for the Chapel Hill SW Scheme. Tender design completed for issue in December. Cookstown Industrial estate works carried out from 6/12/16. Materials for Tay Lane Rathcoole to be procured. Monastery Road and New Road Clondalkin Surface water schemes complete. Poddle River, Camac River, Jobstown Stream and Oldcourt stream works complete. Water Conservation Programme: Repairs of leaks and Bursts by Water Operations for 2016. UFW 33.6% (inc 2016 Census update) Quality 99.96% in 2016 Repairs 538 in 2016 River Basin Plans and Measures: A substantial amount of assessment work has been carried out by the Water Pollution section in the past 12 months which will be a major source of information when preparing the river basin management plan for Cycle 2 of the WFD. Also, all statutory samples collected on time todate this year. Septic tank inspection (2) to be completed later in the year. LIFE application submitted to seek funding to deal with misconnection and prevent polluting material reaching rivers. All other matters regarding septic tank inspections, statutory samples, and dealing with water pollution incidents are on target for 2016. Climate Change: The revised strategy, 'A Draft Strategy Towards Climate Change Action Plans For The Dublin Local Authorities' is to be considered at the next Environment SPC Meeting and will then be brought to the full Council Meeting for adoption. Technical working teams will be reformed in the new year to consider appropriate actions, monitoring and reporting of progress, both unique to our council while considering our common borders with other local authorities.

Objective 3: Manage our regulatory, licensing and enforcement roles together with the Environmental Protection Agency

Waste Enforcement Action: Scheduled inspections and Audits/Reviews undertaken on permitted facilities in accordance with risk rating. Three (3) WFP reviews lodged, Three (3) WFP Validations. Two prosecutions in District Court for illegal waste storage/provision of false information. Conviction, Fine and €7,500 costs awarded against CoR Holder. Second Case adjourned to November 29th on Undertaking to Court for works to be carried out. Unauthorised collectors active in South of County distributing flyers for waste collections, using Social Media to inform public of bogus status. No letters issued for non-compliance of Trade Effluent Licence. Five (5) S14's issued, One (1) warning letter was issued in accordance with the Waste Management Act 1996 as amended. Control of Animals: Control of Horses - 2 seizures / 1 reclaim and 1 dead horse recovered. Control of Dogs - S. 2 fines - 17 S. 9 fines - 1 S.5 fines -0 Total Horses impounded 266 Total Dogs impounded 565 In relation to control of dogs a new tender is being progressed by Dublin City Council. Contract extended until end April 2017. Dublin Noise Action Plan: Environmental Health in conjunction with Traffic Unit of LUPT have completed our evaluation of the round 2 and the differences between 2012 and 2016 road vehicular figures. We have concluded that we will require a partial re-modelling of our county for the length of the M50, N4 and the N7 national roadways. We have submitted this plan to the Environmental Protection Agency last week. Noise is continuously monitored and measured at 10 locations throughout the county of South Dublin. This monitoring is used to correlate with the Noise Modelling and the Noise Maps produced every five years for the SDCC region. The level of correlation at all 10 sites will form part of this study. South Dublin has been

selected along with Kildare and Limerick in a STRIVE small scale noise research project over the next two months. Comparisons and contrasts will be made between Ireland and the Netherlands on the whole field of noise complaints relating to traffic.

#### Objective 4: Maintain and improve our parks and recreation areas to enhance our quality of life

Playspace Programme: During 2016 the Play-space programme delivered as follows: 14 play spaces progressing through planning / design stage at end of 2016, 8 in consultation, 2 completed and opened during 2016, 4 further play spaces under construction with 3 of those to be completed by year end and 1 to be completed early 2017. Provision has been made in the 2017 capital budget to continue to progress the playground provision and expansion programme. Equine Facility: The equine facility at Ballyowen Park was constructed during 2016 and will be substantially complete in January 2017. Pavilion Programme: The initial tender during 2016 for pavilions for the pre-fabricated units was unsatisfactory and an alternate tender process was proposed using design-build with traditional materials for the sports pavilion and car-park in Oldbawn. If successful it can be expanded to address the other pavilions originally included in the programme. Provision has been made in the 2017 capital budget to continue to progress the pavilions programme.
