Dear Ms. Reilly,

While this is a matter for a private developer and not a function of the Department or the Minister, I have contacted ESB and asked them to provide details of the issues on site. They have given me the following update:

"The issue with this site is that there were works that had not been completed by the developer before ESB Networks could go on site to complete connections. ESB gather that ducting – which is a developer responsibility – is only nearing completion now. ESB also understand that due to the way overhead lines are configured at the site, ducting works needed to be completed which will not directly impact on this phase of the scheme...

This ducting requirement would have been discussed with the Developer well in advance of the due date for 'handover.' Now that the ducting side is almost complete, matters are progressing and colleagues in ESB Networks are currently scheduling jointers to terminate and joint cables, install substations and mini pillars etc. "

As previously stated, this is not a matter that I have any role in as Minister but I hope I have been of some assistance in getting you and update.

At the March 2018 Lucan Area Committee Meeting (ACM), the following motion was passed by the members:-

"That this committee requests the Chief Executive to write to the Minister Housing, Planning, Community and Local Government to investigate the significant delay with the ESB and the removal of overhead lines in Adamstown (St. Helens), which are preventing the occupation of completed housing in Adamstown.

Below is the developer's response to date:

'There is an unforeseen delay with the removal of some overhead electrical lines at St. Helens. As is now common practice, these overhead lines need to be removed and supply routed to the site via an underground network. Unfortunately, the ESB have been extremely slow in communicating a date in respect of the aforementioned and our construction team have sought a meeting with them to discuss the seriousness of the situation".

Any reply will be circulated to the Members and will be available to the public by published minutes of the meeting. Your early response would be appreciated.
