Thank you for your email regarding additional bus departures from the Penny hill, Lucan.

Dublin Bus currently operates a 5 minute service on the Lucan corridor during the morning peak. We are closely monitoring passenger loadings on the Lucan corridor and we currently have an Inspector in the area to monitor customer demand. We also filter in 6 additional departures at designated stops which includes the Penny hill area along the corridor, to supplement the service. These extra services were introduced to help meet the additional demand

These additional departures help improve reliability, meet increased customer demand and offer a better journey experience for our customers in Lucan and the surrounding areas.
