Dear Ms Murphy

I am to refer to your recent correspondence and advise as follows:

As I have previously outlined to both the local policing forum meetings at Clondalkin and the Joint Policing Committee for the area, An Garda Siochana is still suffering from the effects of cutbacks which were decided upon a number of years ago.

I can tell you that when I assumed control of the Clondalkin District in 2012 there were two Sergeants, six Gardai per shift (four shifts) and four detectives attached to Rathcoole Garda Station. At this time there is no Sergeant at the station full time and two Gardai per shift and two detectives in the station. Following on from the recent promotion lists I have allocated one Sergeant to Rathcoole Station and it is my intention to transfer further Gardai into the station when they become available.

I can assure you and members of your Committee that I consider Rathcoole to be a priority area and I will strengthen Garda levels as soon as I possibly can.
