There are two main elements to the BusConnects Dublin Programme.

They comprise redesign of the bus network and the implementation of Core Bus Corridors.

In the case of the bus network redesign, the NTA undertook a major public consultation between July and September on its initial proposals. At this stage, the NTA is reviewing the tens of thousands of responses received and it is our intention to publish revised proposals early in 2019 and undertake a further public consultation process at that stage.

In the case of the Core Bus Corridors, the NTA will shortly launch its proposals in the matter and undertake a public consultation on those proposals. There are 16 Core Bus Corridors in total that are planned for development and we will be phasing the publication of the individual corridor consultation details in order to be able to appropriately manage the level of engagement required. The detailed information in respect of the Core Bus Corridors will be available on the BusConnects website in due course (www.busconnects.ie).
