Economic, Enterprise and Tourism Development

Objective 1: Maintain a supportive business environment with job creation and retention at its heart

LEO training schedule continued in October 2018, with Autumn programme ongoing including additional training to be provided under the Business Support Fund, in conjunction with South Dublin Chamber. To end September, 539 clients have attended LEO provided training, with a further 355 attending training provided by South Dublin Chamber, supported through the Business Support Fund. The next Evaluation & Approvals Committee Meeting is scheduled for Tuesday 27th November 2018. 9 Technical Assistance for Micro Exporters grants, including food branding, were approved in 2018 to the end of July to the value €18,634. 25 Trading Online Voucher applications were approved in 2018 with a total value of €51,071.50. The next TOV's seminar is due to take place on January 2019 in the LEO training room. 393 clients availed of in-house clinics/ outreach clinics/mentor assignments to end September 2018. Representatives of Age Friendly Alliance and Tus Nua attended the National Convention Age Friendly Counties in Wicklow in November. Healthy County Committee meeting being convened for December to progress 2019 work plan. Joint Policing Committee held on 23rd November in County Hall and considered An Garda Siochana, LPF and Drug Sub-Sommittee updates as well as GDPR/CCTV, Misuse of Scramblers/Quads and St. Cuthbert's Park. LCDC assessment of applications for additional funding allocated to South Dublin under the Community Enhancement Programme by the Department of Rural and Community Development is now complete and recommendations will be considered by LCDC at its December meeting. Community Endeavour Awards 2018 were held at Red Cow Moran Hotel on Saturday 1st December at which 150+ eligible nominations were considered for awards. 2nd Round of Community Grants approved at November Council meeting - 41 grants in the total sum of €97,204 were approved. New Public Participation Network host organisation now in place. Two of the South Dublin Community Projects won awards at the 16th annual IPB Pride of Place Awards 2018 in association with Co-operation Ireland were announced on Saturday the 17th November at a Gala Awards Ceremony in Cork City Hall with Muintir Chrónáin -Áras Chrónáin securing the Overall Winner Award in the Creative Place Initiative and St Mark's Youth Club – St Mark's Parish, Tallaght picking up the Runner Up Award in Urban Neighbourhoods. LEADER programme ongoing – applications being reviewed and assessed.

Environment, Water & Climate Change

Objective 1: Improve the appearance of our county in the interest of economic development

Public Realm Maintenance: The 2018 Improvement Works programme continues and a revised Maintenance Works Programme will be drawn up following completion of the Public Realm Review Process. N81 Improvement Scheme: Tendered for construction of Phase 1A of N81 Scheme is completed. Letter of intent has been issued. The Pre contract meeting has taken place and contractor is due to start on site. Tree Maintenance Programme: Contract has been awarded for the removal of 88 popular trees within Dodder Valley Park at the rear of Rathfarnham Shopping Centres Service yard. Further contract works are also ongoing at a number of locations where trees are in conflict with overhead electricity wires. A report on the Interterm review of the Tree Maintenance Programme was presented to the November Environment SPC meeting with a view to bringing the final review recommendations to the next SPC meeting in February. Scheduled Street Cleaning Programme: Tender for the Road sweeping services was advertised on the 14th June 2018. Closing date for the tender was extended to July 27th following the issuing of additional information to tenderers. Tender assessment has taken place. Litter Management: Environmental Awareness: The following environmental awareness campaigns are currently being promoted: waste prevention/reusable cups, anti-Litter, anti-dog fouling and Green dog walkers, Conscious cups, Christmas decoration competition opened to schools via social media. Public Realm: Cleansing Schedule continues, pickups for community clean-ups ongoing. The Solar Bin Pilot (agreed for Rathfarnham) tender process underway. Ongoing servicing of Bottle banks / recycling facilities carried out. Continuous clean—ups of areas prone to repetitive instances of illegal dumping (Scheduled and unplanned). Council, through contractor operating leave collections both bagged and sweeps. Halloween: A total of 280 bonfire sites have been recorded in the County in 2018. The Council collected and removed bonfire materials as a priority task through the month of October (and indeed for part of September also). Over the weekend prior to Halloween, a total of 144.4 tonnes of bonfire materials was collected by this Council. In the days immediately after Halloween, from November 1st to 3rd, a total of 51.7 tonnes of waste was removed from bonfire sites. The information available to date indicates that a total of 280 bonfires took place, an estimated 500 tonnes of waste has been

removed including prior to and post Halloween all at an estimated cost of €120,000. The clean-up of sites has now been completed and reinstatement where required will take place in the spring of 2019. Enforcement & Licensing: CCTVs - roving and decoy at 8 locations countywide (13 cameras). Drones used extensively to monitor licenced / permitted sites. CCTV scheme for St Cuthbert's progressing - ESB connection now complete. Meeting of High Level Task Force held 16th November.

Objective 2: Incorporate environmental sustainability in all policy-making and implementation programmes

Climate Change: €10 M funding secured for the national set up and running of 4 regional Climate Change Offices for the next 5 years. The Draft Climate Change Action Plan was presented to the November meeting of the Environment SPC. Eastern/Midlands Regional WMP & WERLA: Inspections in relation to ELVE's (End of Life Vehicles) took place week commencing 17th Sept. We have written to 50 Second hand car importers have inspected 33 to date, in relation to compliance with EU (End of Life Vehicles) Regulation 2014. Inspections of Suspected Major Producers of packaging complete and case closed on 16 of 20 identified companies. Communication ongoing with remaining companies. Surface Water Schemes: Schemes for 2018 nearing completion. Upgrade to the remote monitoring of the Poddle screens, works in Glenmaroon, works on Peamount Road, works on the Pond at Rathfarnham Castle and on the SW Culvert on Stocking Lane all completed. Works on Ballyowen Lane ongoing. Surveying work in Templeogue Village complete, ongoing liaison with Roads Department and Irish Water in relation to scheme commencement. Flood Alleviation Schemes: Whitechurch FAS - Appointment of RPS Consultants. Camac - Consultants brief under peer review. Poddle FAS - flow and rainfall survey extended. Meeting with the local stakeholders has also commenced and will continue. River Basin Plans and Measures: Launch of the Dublin Urban Rivers Life Project has taken place at Rathfarnham Castle. Report to September SPC. Business cases being prepared to commence recruitment process. Water Services: Repairs of leaks and bursts by Water Operations ongoing. EPA carried out Audits on the Public Water Supply in South Dublin and Fingal on 22nd August and on the Private Water Supplies in South Dublin on 23rd August - audit reports awaited.

Objective 3: Manage our regulatory, licensing and enforcement roles together with the Environmental Protection Agency

Waste Enforcement Action: Enforcement / surveillance services (Litter and Waste) continues. Continued interdepartmental liaison to develop common approach to common issues. Continued monitoring of high level activity sites. Control of Animals: Temporary Contracts for Control of Horses and Dogs rolled over pending finalisation of procurement process. 22 - 10 Day Notices issued for Dogs. 5 Horses seized. Air Quality: National Clean Air Strategy launched. Regulations are currently being finalised. The ban on the sale of smoky coal which has been in place in larger towns for some time, will be extended countrywide from autumn of 2018. Mandatory legislation requirements for installation of stoves being considered by the department at the moment. Dublin Noise Action Plan: SDCC noise maps and action plans are now available for public consultation until Monday the 17th of December. To date i.e. end of November there have been 4 submissions on the plan.

Objective 4: Maintain and improve our parks and recreation areas to enhance our quality of life

Regional and Local Parks: Proposal for new regional park maintenance structure is included in the Public Realm Review proposals. Signage erected re dogs on leads (except in dog-runs). Play-space Programme: Tender awarded for Waterstown, contractor is on site. The Council have appointed contractors to install play spaces in Ballymount Park, Glendown Park, Bancroft Park, Lucan demesne and Whitechurch. 7 further tenders underway. Teen Space Consultation: Meeting with Community, Comhairle na Nog, Crosscare and Foroige completed. Targeted workshops completed. Final projects being planned to commence in 2019 Recreational and Sporting Facilities: Hermitage Frame Football project opened. Pavilion Programme: QS tendered for construction tender at tender assessment stage for Dodder Valley Mt Carmel; Ogham Tree Trail signage completed, tree supply tendered. Site investigations completed. Delivery of objectives in the Tourism Strategy Corkagh Park Recreational Project re-tendered. Brief agreed. Tender issued.
