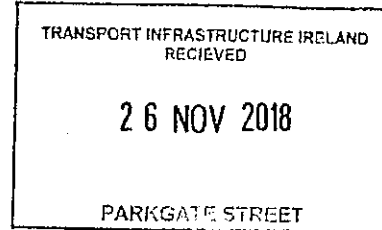


Re: Clondalkin Area Committee Meeting of South Dublin County Council

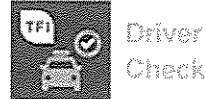
