- Provide an **enhanced urban realm** & streetscape




Scheme Background


- Previous Part 8 for 'Wellington Lane Whitehall Road Cycle Track -**Scheme'** was approved with amendments in 2012
- Upon analysis the scheme as amended was deemed unacceptable to -SDCC on the grounds of Health & Safety
- Subsequent Issue of National Guidance (DMURS, 2013) also established the principles of **prioritising sustainable modes** and **sense of place** over movement of private vehicular traffic in urban areas
- DMURS advocated a more holistic approach to street design to create -'safe, attractive and vibrant streets'




Reimagining the Wellington Lane Walking & Cycling Scheme

- **Safety** issues; alterations to current layout recommended by jury of coroners court in respect of fatality at Templeville Roundabout
- Multi disciplinary team appointed to re-examine the issues holistically, to develop safety improvements for all road users but also to deliver place making and urban realm enhancements
- Greater public engagement to be a key facet of the scheme







Process Overview
