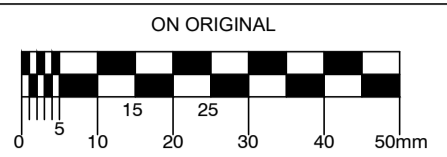

1. ALL WORKS SHALL BE CONSTRUCTED IN ACCORDANCE WITH THE WORKS REQUIREMENTS.
 2. ALL DIMENSIONS IN METRES UNLESS SPECIFIED OTHERWISE.
 3. ALL CO-ORDINATES ARE TO IRISH TRANSVERSE MERCATOR.
 4. ALL LEVELS ARE TO ORDNANCE DATUM (MALIN HEAD).
 5. ALL TEMPORARY TRAFFIC MANAGEMENT SHALL COMPLY FULLY WITH THE WORKS REQUIREMENTS - REFER TO APP 17/17.
 6. THE CONTRACTOR MUST LAISE DIRECTLY WITH SOUTH DUBLIN COUNTY COUNCIL DEPARTMENTS AS DIRECTED IN THE WORKS REQUIREMENTS.
 7. ALL VEHICULAR, PEDESTRIAN & CYCLE ROUTES WITHIN AND SURROUNDING THE WORKS EXTENTS MUST BE MAINTAINED THROUGHOUT THE WORKS IN ACCORDANCE WITH THE CONTRACTOR'S APPROVED TEMPORARY TRAFFIC & OPERATIONS MANAGEMENT PLAN.
 8. ALL PERMANENT TRAFFIC MANAGEMENT TO BE CONCEALED/REMOVED OR INCORPORATED INTO THE CONTRACTOR'S TEMPORARY TRAFFIC MANAGEMENT PLAN THROUGHOUT WORKS AND TRANSFERRED ONLY WHEN AGREED WITH SDCC TRAFFIC DEPARTMENT.
 9. BUS SHELTERS/STOPS SHALL REMAIN OPERATIONAL THROUGHOUT WORKS AND ONLY BE REMOVED WHEN DIRECTED BY THE EMPLOYERS REPRESENTATIVE IN CONSULTATION WITH BUS CREWMAN AND LOCAL BUS OPERATORS.
 10. THE CONTRACTOR IS RESPONSIBLE FOR THE ONGOING MAINTENANCE OF TRAFFIC SIGNALS FROM THE STARTING DATE TO SUBSTANTIAL COMPLETION. THIS INCLUDES ALL TEMPORARY TRAFFIC SIGNALS WHILE IN TRANSITION BETWEEN THE CURRENT TRAFFIC MANAGEMENT REGIME AND THE PROPOSED TRAFFIC MANAGEMENT REGIME.
