# PART II Pay and Display Ticket Parking

Conditions for Parking in pay parking places

6.

- (1) The following provisions shall apply during operational hours to the parking of a vehicle in a pay parking place:
  - (a) subject to paragraph (2) of this Byelaw, a vehicle which is parked in a pay parking place during operational hours shall, where parking bays are provided at that pay parking place, be parked within the area comprising a pay parking bay,
  - (b) a vehicle which had been parked in a pay parking place for the maximum period permitted in that pay parking place, as indicated on the appropriate pay and display ticket parking machine in accordance with Bye-Law 14, shall not be parked again in a ticket parking place on the public road or car park in which that pay parking place is situated until at least one hour has elapsed since the vehicle was last parked in that pay parking place,
  - (c) a vehicle shall not be parked in a buffer area,
  - (d) a vehicle parked in a pay parking place at a time which is not during operational hours shall be removed from the pay parking place when a period of operational hours commences, unless at such commencement and during the remainder of the period of parking, a valid pay and display parking ticket or valid residents parking permit or a valid visitors parking permit is exhibited in the interior of the vehicle in accordance with Bye-Law 7 of these Bye-Laws and these Bye-Laws shall apply from the commencement of such parking,
  - (e) where a vehicle being parked in a pay parking place during operational hours is a goods vehicle parked while goods are being actively loaded in or on to it or unloaded from it paragraph (1) of Bye-Law 7 shall not apply until the expiration of 30 minutes after the commencement of the parking,
  - (f) a person shall not overhaul or carry out repairs to a vehicle while it is parked in a pay parking place, save where it is necessary in order to enable the vehicle to be removed from the pay parking place

- (g) a vehicle, while parked in a pay parking place, shall not be used for the sale of goods in or from the vehicle or as an office; nor shall any such vehicle be offered or displayed for sale or for hire or as a prize. A person shall not make any unnecessary noise by means of, or in relation to, a vehicle while it is parked in a pay parking place, or by means of any equipment, fitting or instruments fitted to or carried on the vehicle or any loud speaker or radio in anyway connected to the vehicle.
- (2) Notwithstanding paragraph (1)(a) of this Bye-Law, a vehicle parked in a pay parking bay during operational hours may project into an adjoining buffer area if the length of the vehicle prevents its being parked wholly in accordance with paragraph (1)(a) of this Bye-Law.
- (3) This Bye-Law shall not apply to a pay parking bay when the pay and display parking ticket machine for that parking bay is temporarily suspended from operation in accordance with Bye-Law 10.
- (1) Where a vehicle is parked in a ticket parking place during operational hours -
  - (a) A valid pay and display parking ticket shall be displayed as specified in this Byelaw on the interior of a vehicle lawfully parked in a ticket parking place at the commencement of the parking;
  - (b) the valid pay and display parking ticket shall be so exhibited in the interior of the vehicle in a manner which will permit a person outside the vehicle to see clearly all the information indicated on the said ticket and sufficient to enable such person to ascertain by reference to the ticket when such parking commenced.
  - (c) the valid pay and display parking ticket shall be exhibited in accordance with paragraph (b) of this Byelaw so long as the vehicle is parked in that ticket parking place.
  - d) a 15minute grace period, after the expiry of a paid ticket will be applied
  - e) a minimum payment of €0.50 must be paid for any parking in a pay and display bay.
- (2) Where a vehicle is parked in a residents parking place during operational hours
  - (a) A valid residents parking permit or valid visitors parking permit or valid pay and display parking ticket shall be displayed as specified in this Byelaw on the interior of a vehicle lawfully parked in a residents parking place at the commencement of the parking.

Obligation to display 7. valid parking ticket/permit

- (b) the valid residents parking permit or valid visitors parking permit or valid pay and display parking ticket shall be so exhibited in the interior of the vehicle in a manner which will permit a person outside the vehicle to see clearly all the information indicated on the said permit or ticket.
- (c) the valid residents parking permit or valid visitors parking permit or valid pay and display parking ticket shall be exhibited in accordance with paragraph (b) of this Byelaw so long as the vehicle is parked in that residents parking place.
- Parking permits shall be issued and distributed by the Council or its agents

(a) A pedal cycle shall not be parked during operational hours in pay parking places.

- (b) A large public vehicle shall only be parked in a pay parking place during operational hours, where traffic sign number RUS019 accompanied by an information plate containing the words 'except buses – ach amháin busanna' is provided.
- (a) The Council or its agents may at its discretion suspend from operation any pay and display parking ticket machine(s) or a pay parking place(s).
- (b) Where the suspension is at the request of a person, organisation or agency, the suspension shall be subject to any conditions which may be specified in writing by the Council, including the payment of a fee/fees by the person, organisation or agency requesting the suspension
- (c) The maximum fee/fees payable for suspension or renewal shall be as indicated in Schedule 1.
- (d) The suspension of a pay and display parking ticket machine or a pay parking place shall be indicated by the placing thereon of a sign or other device clearly indicating that it is non-operational or by the temporary removal of the pay and display parking ticket machine and the erection of a sign indicating that the parking of vehicles is prohibited in the pay parking place.
- (e) It shall be an offence to breach a condition specified in writing by the Council when a pay and display ticket parking machine or a pay parking place is being suspended. In the event of vehicles being parked in contravention of these conditions they shall be deemed to be unlawfully parked for the purposes of the Road Traffic Acts and any Regulations made thereunder.

13. The parking fee payable for a pay and display parking ticket are shown in Schedule 1.

Manner and time of payment of parking fee

14.

- (1) A pay and display parking ticket shall be purchased from an appropriate pay and display parking ticket machine
- (2) The fee for the pay and display parking ticket shall be payable by means of any combination of valid coins, or, where the facility is provided, by payment card or by mobile phone payment. The method/methods of payment will be indicated on the pay and display parking ticket machine.
- (3) Payment by cash shall be made by inserting the appropriate fee for the parking time required into the appropriate pay and display parking ticket machine and following the instructions on the parking ticket machine in order to obtain a valid pay & display parking ticket.
- (4) Payment by payment card shall be made by inserting the payment card into the pay and display parking ticket machine and following the instructions on the parking ticket machine in order to obtain a valid pay & display parking ticket.
- (5) Payment by mobile phone shall be made by connecting to a pre-registered site and following the instructions on the phone or the pay and display parking ticket machine in order to obtain a valid pay and display parking ticket.
- (6) The valid parking ticket shall be displayed immediately on parking provided that, where a vehicle is parked at a time not during operational hours, the valid pay and display parking ticket shall be displayed in accordance with Bye-Law 7 at the commencement of operational hours.

A vehicle parked in a ticket-parking place during operational hours shall not be so parked for a period longer than the maximum period for which parking is permitted on that day in that ticket parking place as indicated on the appropriate parking ticket machine or information plate located on the public road or car park in which the vehicle is parked or located on an adjacent public road, where indicated by a sign. Refer to Appendix 2 for maximum durations. An exception to the maximum parking period may apply in the following circumstances:

- a) EV's using an electrical charge point in a public area. This exception will be shown on the accompanying street signs if applicable.
- b) Car club Vehicles displaying a valid Car Club vehicle permit.
- c) Vehicles displaying a valid disabled persons parking permit

## **PART III Car Club Parking Licence**

Applying for an operator licence

#### 16. Car Club Parking Licence

- (a) The car club operator shall provide the Council with a vehicle registration number and such other details as the Council shall deem appropriate, in respect of each vehicle, before, and in order to ensure the issue of a car club parking licence
- (b) An applicant shall apply to the Council for a car club parking licence to operate within the Council's Administrative area and must be granted such a car club licence by the Council, prior to commencing operation.
- (c) A car club parking licence shall be valid for an initial period of twelve months, and, subject to the Council being satisfied with the operator, it shall be renewable thereafter every twenty four months, or such shorter period as may be deemed appropriate in the absolute discretion of the Council.
- (d) A car club parking licence shall be granted only where the following conditions have been met by the operator:
  - i. The applicant has paid the Council the licence fee of €100 per annum.
  - ii. The Council is satisfied that the applicant will comply with the provisions of these Bye-Laws and all statutory requirements
- (e) A car club operator shall not operate, or permit to be operated, its car club service without holding a current car club parking licence in respect of that service. A permit shall also be required for each car club vehicle
- (f) The maximum number of car club vehicles to be operated under any one car club parking license is 25.

Good industry practice 17.

The holder of such a licence shall at all times engage in good industry practise and satisfy all statutory requirements.

- Return of resident's 22. Where, during the period to which a resident's parking permit relates, parking permit the holder ceases to reside at the address notified at the time of issue of the permit or ceases to be an owner by disposing of the vehicle to which the permit relates, he/she shall return the resident's parking permit to the Council or its agents. Transfer of resident's 23. If the holder of a resident's parking permit for a vehicle replaces that parking permit vehicle with another he/she shall be entitled, following the surrender of the original permit, to receive a resident's parking permit in respect of the new vehicle which shall be valid for the period specified on the original permit.
- *Renewal of Resident's* **24.** The Council may renew a resident's parking permit on submission of a completed application form and on payment of the appropriate fee without submission of 'acceptable evidence';
- Provision of Acceptable Evidence
  25. (1) At any stage prior to the expiry of a resident's parking permit the Council may request the person to whom a permit was issued to produce 'acceptable evidence' to satisfy the Council that they were entitled to be issued with the permit. Any such request will be made in writing to the person to whom the permit was issued at the address given by that person on the application form;
  - (2) In the event of 'acceptable evidence' not being produced to the Council within one month from the date of the written request the Council may, at its discretion, deem the resident's parking permit to be invalid and cancel the permit without further notice.
- *Display of a void* 26. It shall be an offence to display a void or expired resident parking permit.
- *Issue of Resident parking* 27. *permits to non-resident family members:* A Resident Carers Parking Permit may be issued to a dwelling occupied by a person requiring ongoing daily care and assistance. This parking permit shall be issued annually subject to written confirmation from the resident's doctor that the resident requires such assistance.
- *Falsified documents:* 28. Where a resident or applicant submits falsified documentation to support his/her application for a resident's parking permit the application will be denied, and the applicant will incur a ban on future applications, duration to be decided by the Council.

Issuing of complimentary parking permits and provisional parking permits:

**29.** The Council may issue complimentary and provisional parking permits which when correctly displayed in a vehicle, will enable that vehicle to be parked in any ticket parking place, to which these Byelaw's relate, without displaying a valid pay and display parking ticket, resident's parking permit or visitor parking permit, provided that the vehicle is otherwise legally parked, and subject to compliance with the conditions set out on the complimentary parking permit.

### **PART VI Commercial Parking Permits**

- **33.** A valid Commercial Parking Permit shall contain the following particulars;
  - (1) the words 'South Dublin County Council'
  - (2) the parking place to which it relates
  - (3) the make, model and registration number of the vehicle in respect of which it is issued;
  - (4) the date of expiry;
  - (5) the signature of the person issuing it.
  - **34.** In the event that greater than the number of commercial parking permits for any area, as specified in Appendix 2, are applied for by Qualifying Commercial Businesses, the parking permits will be issued at the discretion of the Local Authority.
  - **35.** The display in accordance with Bye-Law 7 of a valid commercial parking permit on a vehicle in respect of which the parking permit was issued shall permit the owner of the vehicle (or any person using it with his/her consent) to park it without limitation as to duration, unless otherwise stated on the information plate, in the designated Pay and Display Pay and Display Ticket Parking Places or car parks denoted within Appendix 2 of these Byelaws.
  - **36.** (1) A commercial parking permit may be issued by the Council or its agents only, in respect of the parking of a vehicle in the designated Pay and Display Pay and Display Ticket Parking Places or car parks denoted within Appendix 2 of these Byelaw's.
    - (2) The fee for each parking permit shall be as indicated in Appendix 1.
    - (3) A parking permit shall be valid up to and including the expiry date shown on the parking permit, in respect of that vehicle and for the parking places to which the permit relates.

# **PART VII Car Club Parking Permits**

#### 'Applying for a car club parking permit

**41.** (a) A licenced parking operator shall apply to the Council for a permit for each vehicle to be used as part of a car club. The fee for each such permit shall be €500.

#### 'Particulars of car club parking permit

**42.** A valid car club parking permit shall contain the following particulars:

- (a) The words 'South Dublin County Council'.
  - (b) The make, registration number of the vehicle in respect of which the said permit is issued.
  - (c) The date of expiry of the car club vehicle permit.

#### Issue of, and fee for car club parking permit

**43.** (a)A car club parking permit may be issued by the Council or its agents only on receipt of an application from an Licenced Car Club parking operator for each vehicle used as part of a car club.

(b)These permits are valid within pay and display areas operated by the Council. ©A parking permit shall be valid up to and including the expiry date shown on the car club parking permit.

#### 'Permission to park vehicle displaying valid car club parking permit'

**44.** (a) A car club vehicle with the proper permit displayed may park in a paid parking place, in a paid parking area on a public road or in a car park intended for the parking of mechanically propelled vehicles.

(b) A permitted car club vehicle is authorised to park a car club vehicle in a disabled person's parking place, if the car club vehicle displays a valid disabled person's parking permit at that time and the said car club user is entitled to use such a valid disabled-person's parking permit. A car club vehicle may not be left in a disabled person's parking place once the car club user holding the disabled persons permit has finished using the car club vehicle.

#### 'Replacement / Cancelation of car club parking permit'

**45.** Where the Council is satisfied that a car club vehicle permit has been lost, destroyed or stolen, the Council, or its agents, shall issue a replacement permit to the relevant operator on payment of such fee €125 as determined by the Council, and such replacement permit shall be substituted for the original permit, and the original permit shall be cancelled.

The Council may cancel a car club licence where it believes that the operator no longer meets the requirements for a car club licence to be issued in accordance with these Bye-Laws.

# PART VIII **General Regulation of Parking of vehicle Restrictions** and Prohibitions

Parking within areas which do not fall under "Pay and Display", Particulars of parking 46. "Residents Parking" or "Commercial Parking" must adhere to 'The Road Traffic (Traffic and Parking) Regulations 1997 SI 182/1997'. These rules apply to the entire area of application of these Bye-Laws as outlined in Map A

47. Prohibitions on Parking

(1) Save as otherwise provided for in these Regulations and subject to article 5, a vehicle shall not be parked on a public road at a location, in a manner or for a purpose referred to in this article.

(2) A vehicle shall not be parked-

(a) on that side of a section of roadway along the edge of which traffic sign number RRM 008 [double yellow lines] has been provided:

(b) on a section of roadway where traffic sign number RUS 019 [No Parking sign] has been provided, during the period indicated on the information plate accompanying such traffic sign;

(c) within 5 metres of a road junction;

(d) on a section of roadway with less than 3 traffic lanes and where traffic sign number RRM 001 [continuous white line] has been provided;

(e) on a section of roadway where traffic sign number RUS 020, in association with RRM 029 [appointed stand], has been placed to indicate that an appointed stand has been provided; (f) in any place, position or manner that will result in the vehicle obstructing, delaying, or interfering with the entrance to or exit from a fire brigade station, an ambulance station or a Garda station:

(g) in any place, position or manner that will result in the vehicle obstructing an entrance or an exit for vehicles to or from a premises, save with the consent of the occupier of such premises;

(h) within 15 metres (on the approach side) or 5 metres (on the side other than the approach side) of a section of roadway where any of the following traffic signs have been provided-

(i) traffic sign number RPC 001 [Pedestrian Crossing];

(ii) traffic sign number RPC 002 [Pedestrian Crossing Complex]; or

(iii) traffic sign numbers RTS 00I, RTS 002, RTS 003 or RTS 004 [traffic lights];

(i) on a footway, a grass margin or a median strip;

(j) on a part of a roadway which is a casual trading area, during hours of trading, unless the vehicle is for the time being in use for the purposes of casual trading;

(k) in a manner in which it will interfere with the normal flow of traffic or which obstructs or endangers other traffic;

(I) where traffic sign RUS 031 [bus stop] or RRM 030 [stopping place or stand] has been provided unless the vehicle is an omnibus.

(1) A vehicle shall not be parked during a period which may be indicated on an information plate, on that side of a section of roadway along the edge of which traffic sign number RRM 007 [single yellow line] has been provided.

(2) (a) Subject to paragraph (b), where traffic sign number RUS 018 [Restricted Parking] is provided a vehicle may only be parked for the length of time and, where appropriate, during the period, indicated on the information plate accompanying the sign.

( b ) Subject to article 43(3), where a vehicle is removed from a place in respect of which paragraph (a) applies it may not be parked again in that place within one hour of its removal during the period when the restriction is in force.

(3) (a) Subject to paragraphs (b) and (c), a vehicle, other than a large public service vehicle, shall not be parked where traffic sign number RUS 019 [No Parking] accompanied by an information plate containing the words "Except Buses - Ach Amháin Busanna" is provided.

(b) (i) The restriction referred to in paragraph (a) may be applied for a specific period which shall be indicated on an information plate.

(ii) A large public service vehicle parked in accordance with paragraph (a) shall not be parked for a period exceeding one hour from the commencement of such parking.

(c) Where a large public service vehicle, having been parked in that portion of a roadway where the restriction as provided for in paragraph (b) applies, leaves, it shall not be parked again in that portion of the roadway within one hour of leaving while the restriction applies.

(4) Where a vehicle is parked in a parking place which is the subject of a provision contained in bye-laws made under section 36 of the Act of 1994 it shall only be parked in accordance with such a provision.

(5) Where traffic sign number RRM 011, RRM 012, RRM 013 or RRM 014 [Parking Bays] is provided, a vehicle must be parked within the limits of the parking bay.

(a) Subject to sub-article (2), where traffic sign number RRM 015 [Disabled Persons Parking Bay] is provided, a vehicle shall not be stopped or parked.

(b) Sub-article (1) shall not apply to a vehicle in which is displayed a disabled person's parking permit, and which is parked for the convenience of the person to whom the permit was granted.

Pedestrianised Streets 56. (a) A person shall not drive a vehicle into a road, a portion of a road or an area, at the entrance to which traffic sign number RUS 021 [Pedestrianised street or area] has been provided, during the period indicated on the information plate accompanying the said traffic sign.

> (b) A vehicle shall not be parked in a road, a portion of a road or an area, at the entrance to which the traffic sign referred to in sub-article, (c) is provided, during the period indicated on the information plate accompanying the said sign.

> (d) Where a vehicle is parked in a road, a portion of a road or an area, at the entrance to which the sign referred to in subarticle (1) is provided, at a time in advance of the commencement of the period indicated on the information plate accompanying the said sign, the parking of the said vehicle must cease and the vehicle must be removed from the road. portion of the road or the area prior to the commencement of that period.

### PART IX Miscellaneous

57. Non-application of Bye-Laws:

Bye-Laws 6 to 15 of these Bye- laws shall not apply to -

- (1) a vehicle being used specifically in connection with the removal of an obstruction to traffic, the removal of a vehicle pursuant to Section 97 of the Road Traffic Act 1961 as amended, the immobilisation and release of vehicles, the maintenance, improvement or reconstruction of a public road, the provision, alteration or repair of a main drain, pipe or apparatus for the supply of gas, oil, water or electricity or of a telephone line or the provision of a traffic sign,
- (2) a fire brigade vehicle, an ambulance, a vehicle being used by a traffic warden or for the collection of refuse, an authorised person or a member of the Garda Síochana or the Defence Forces in the performance of his/her duties as such member,
- (3) a vehicle in which a valid disabled persons permit is displayed and which is parked for the convenience of the person to whom that permit was granted if the permit is prominently displayed on the vehicle when that vehicle is parked in a pay and display ticket parking place, or a residents parking place on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997.
- **Disclaimer** 58. In accordance with Section 36(13) of the Road Traffic Act, 1994, the performance by the County Council or its agents of their functions under these Bye-Laws shall not render the Council subject to any liability in respect of loss of or damage to any vehicle in a parking place or the contents of such vehicle.

- Continuity of repealed 59. Bye-Laws and Transitional Provisions:
- (1) Nothing in Bye-Law 4 shall affect the validity of anything done under the 2010 Bye-Laws. Any actions taken under the 2005 Bye-Laws or any other thing done shall not be invalidated by any repeal of the said Bye-Laws but shall, if in force immediately before the said repeal was affected, have effect as if made or done under the 2010 Bye-Laws unless otherwise provided;
  - (2) The continuity of the operation of the law relating matters provided for in the repealed 2010 Bye-Laws shall not be affected by the substitution of these Bye-Laws for the said 2010 Bye-Laws and –

- (a) so much of any other Bye-Law, act or document refers, whether expressly or by implication, to, or things done or falling to be done under or for the purposes of, any provision of these Bye-Laws, shall, and so far as the nature of the subject matter of the other Bye-Law, act or document permits, be construed as including, in relation to the times, years or periods, circumstances or purposes in relation to which the corresponding provision in the repealed 2005 Bye-Laws has or had effect, a reference to, or, as the case may be, things done or falling to be done under or for the purposes of, that corresponding provision;
- (b) so much of any other Bye-Law, act or document (whether repealed, passed or made after the commencement of these Bye-Laws) as refers, whether expressly or by implication, to, or to things done or falling to be done under or for the purposes of, any provision of these Bye-Laws, shall, if and so far as the nature of the subject matter of the other Bye-Law, act or document permits, be construed as including, in relation to the times, years or periods, circumstances or purposes in relation to which the corresponding provision in the repealed 2005 Bye-Laws has or had effect, a reference to, or, as the case may be, things done or falling to be done under or for the purposes of, that corresponding provision.

The Council shall determine policy that should set out the guidelines for operation and enforcement of paid parking/restricted parking/local parking areas. The Policy (appended in Appendix A) as determined by the Council shall be governed, administered and enforced under the provisions attaching to the policy as determined by the Council and relevant governing legislation.




