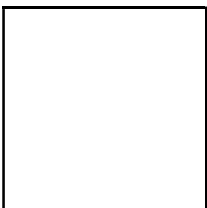
The following motion was passed at the November 2021 Lucan ,Palmerstown & North Clondalkin Area Committee Meeting.
