The existing Building Momentum Agreement - A new public service agreement, 2021-2022 provided for headline pay adjustments of 3%. As you are aware, talks recently concluded between the relevant parties on an extension to Building Momentum. These talks came about in response to the higher than anticipated levels of inflation that have emerged since 2021. The proposed Extension to Building Momentum 2022-2023 provides for three additional adjustments totalling a further 6.5% over 2022 and 2023. These are:

- An increase in annualised basic salaries for public servants of 3% backdated to 2 February 2022.
- An increase in annualised basic salaries for public servants of 2% on 1 March 2023.
- An increase in annualised basic salaries for public servants of 1.5% or €750, whichever is greater, on 1 October 2023.

The extension would make Building Momentum a three year pay deal. The extension acknowledges in particular the higher than anticipated rates of inflation referenced above and in particular the impact of cost of living pressures.

In total, including the existing Agreement and the extension, headline benefits over the lifetime of Building Momentum amount to 9.5%, or just over 3% per year. In respect of public servants at lower pay levels, the extended Building Momentum provides for increases of 12.5% over its lifetime, which is an average of just over 4% per annum. The proposed package has now gone been approved by ICTU.
