### Purpose of Outline Delivery Plan

This Outline Delivery Plan contains concept designs of interventions to improve infrastructure outside and on the routes to school with the aim of increasing the number of children who walk, cycle or scoot to school. These proposed interventions are based on survey findings, audits, consultation with the school and the Local Authority, and have been reviewed by the NTA and have been developed by the Safe Routes to School Officer.

The proposed interventions will require further work including detailed design, and input from stakeholders such as landowners and the local community. Some interventions may require planning permission. It is important to note that concepts and agreed solutions may not progress at the same time and some concepts may not be suitable, however all parties aim to work together to improve infrastructure in and around schools.

There is currently funding available to Local Authorities from the NTA to progress works arising from the Safe Routes to School programme.

### School Summary

- Riverview ETNS is a mixed primary school with approximately 180 students and 19 staff attending the school daily.
- Riverview ETNS opened in 2016 and currently operates a single stream of classes for children from Junior Infants to Fourth Class.
- The school aims to cater for a double stream of classes from Junior Infants to Sixth Class in two years time.

### Key Audit Findings

- Inadequate signage, road markings and traffic calming measures on Limekiln Road on the approach to school.
- There are 17 angled perpendicular car parking spaces at the front of school.
- Dangerous and illegal parking occurs on footpaths on Limekiln Road during school drop off and collection times.
- Children and parents cycling on Mountdown Park have to cross Limekiln Road twice to access the front of school. As there is no crossing provision at Mountdown Park or at the front of school, cyclists mount the footpath on Limekiln Road (at the Mountdown Park junction) and cycle on the footpath to the front of school.
- Pedestrian and cycling links to school can be improved by the removal of kissing gates on routes to school.
- The school currently has no cycle access at the front of school.
- The speed limit outside the school is: Periodic 30km/h (reduced from 50km/h) during school times.
- A pedestrian crossing is located approximately 80m west of the school entrance, however there is no pedestrian crossing at the front of school.
- There is no traffic warden at the front of school.

### Supplementary information

- Riverview ETNS is due to expand into the school building of Setanta Special School in two years time.
- The school started the D12 Bike Bus which operates every Friday and is used by 20 families in the school.
- The school has a large catchment area, with only 22% of the students surveyed starting their journey within 1km of the school.
- The nearest Park and Stride location is the Tymon Park carpark on Limekiln Road, which is approximately 900 metres (15 minute walk) from the school.
- There is a public bus stop for the 15a bus approximately 50m from the school entrance.

# RIVERVIEW ETNS

### **Current Front of School Environment**



The front of school environment of Riverview ETNS is not clearly defined and there are inadequate traffic calming measures on Limekiln Road on the approach to the school. Traffic congestion at the front of school and traffic speeds on Limekiln Road pose a safety hazard for children accessing the school. Dangerous parking occurs along the footpaths on Limekiln Road during school opening and closing times, reducing the space and visibility of children walking and cycling to school. There are 17 angled perpendicular car parking spaces on Limekiln Road at the front of school, with drivers observed reserving onto Limekiln Road when children were accessing the school. There is no pedestrian crossing at the front of school and the school does not have a traffic warden, however there is a pedestrian crossing 80 metres west of the school entrance. There are currently no cycling facilities at the front of school along Limekiln Road.


### **Key Survey Findings**

The school distributed the SRTS Parents Survey to all families of Riverview ETNS. There was a 70.0%<sup>\*</sup> response rate to the survey.

- 87.5% of parents surveyed agreed that road safety is a problem around the school
- **95.5%** of parents would support works at the **front of school** that improve student safety, putting pedestrians and cyclists first




# Where students are travelling from






78 students (61.9%) start their journey within a 2km radius of the school

### How students surveyed (126) are travelling to school




# How students within a 2km radius (78) are travelling to school

### Front of School Improvements

A proposed School Zone on Limekiln Road provides students a safe space to access school and includes traffic calming measures and colourful elements highlighting the presence of children. Consideration should be given to removing the on street parking at the front of school to facilitate the continuation of proposed cycle infrastructure to the front of school. The map below outlines potential measures as suggested by the SRTS Infrastructure Officer.



#### a. School Zone

- Removal of on street parking at front of school
- Application of buff coloured surface at the front of school (SZ-116)
- Pencil bollards along footpaths to highlight the front of school
- Continuation of segregated cycle track to the front of school
- Removal of in situ speed cushions within school zone
- Micro art on footpaths

#### **b. School Zone Gateway Elements**

- School road markings at school zone gateway (SZ-114)
- School Zone Banners and gateway totem banners hung from existing street-lights (avoid excessive poles) (SZ-133)
- 'Fake' speed ramps, e.g. no vertical deflections (SZ-115)

#### c. Crossing Facilities

 Toucan crossing at the front of school to facilitate pedestrians and cyclists (SZ-103)

#### d. Shared Surface Path

- Consider shared surface path from Mountdown Park junction to school entrance
- Rain garden buffer between shared surface
  path and carriageway

#### e. Junction Tightening

 Junction tightening with continuous footpath/raised crossings to be provided across all entrances/junctions within school zone extents and along pedestrian routes to school (SZ-105)

#### f. Cycling Links

- Segregated cycle track on both sides of carriageway at front of school to connect to the wider Wellington Lane Cycle Scheme
- Rain garden buffer between cycle track and carriageway or pencil themed bollards to protect cyclists and prevent parking on cycle track



### Routes to School Improvements

Pedestrian links to Riverview ETNS can be enhanced through improved pedestrian crossing facilities and removal of kissing gates on routes to school. The SDCC carpark in Tymon Park is a potential Park N Stride location. Additional cycle links to the proposed wider cycling network as well as traffic calming measures on secondary roads can improve cycle access to the school. The map below outlines potential measures as suggested by the SRTS Infrastructure Officer.



#### a. Proposed Park N Stride Location

Park N Stride from Tymon Park carpark (900 m)

#### **b.** Crossing Facilities

- Controlled pedestrian crossing facilities on Limekiln Avenue (at Limekiln Road junction)
- Controlled pedestrian crossing facilities on Wellington Lane (at Limekiln Road junction)
- Upgrade pedestrian crossing facilities on Limekiln Lane (at Whitehall Road junction) to provide additional space for pedestrians

#### c. Walking Links

- Wayfinding elements in Tymon Park from proposed Park N Stride location to school
- Widening of footpaths and way finding elements along permeability link from Glendown estate to Wellington Lane

#### d. Traffic Calming

- Reduction in speed limit from 50 km/h to 30 km/h on Limekiln Avenue
- Chicanes or build outs along Limekiln Avenue from Temple Manor Drive to Limekiln Road

#### **e**. Junction Tightening

Junction tightening with continuous footpath/raised crossings to be provided across all entrances/junctions within school zone extents and along pedestrian routes to school (SZ-105)

#### f. Cycling Links

- Cycling facilities on Whitehall Road West to connect to Wellington Lane scheme and D12 Bike Bus scheme
- Widening of path in Greenhills park to shared cyclist/pedestrian facility

#### g. Accessibility

- Removal of kissing gates at following locations:
  - Tymon Park entrance opposite Limekiln Manor
- o Tymon Park entrance opposite Limekiln Avenue
- Greenhills Park entrance on Limekiln Lane
- Greenhills Park entrance on Temple Manor
- Widen entrance on Wellington Lane to permeability link connecting to Glendown Estate

#### h. Modal Filter

- Consider a modal filter at the junction of Fernhill Road and Mountdown Avenue
- Consider a modal filter at the junction of Limekiln Drive and Wellington Road















### Q5. For each child, choose how they usually travel to school






# Q6. Do you think road safety is a problem around your school?





The SRTS Infrastructure Officer conducted the audit to assess the safety and accessibility of the front of school and opportunities to facilitate active travel on routes to school.


A separate GIS analysis of where students started their journey to school identified the primary routes to school.


