1 | Foreword

Thankfully, 2022 was a less eventful year than 2021 for the LCDC.

While life returned to some kind of normality for most of us, it is clear that the longer-term impact of the pandemic will continue to play out across society. We see that in all kinds of ways: the reluctance of older people to go out and socialise as they did in the past; the difficulties with engaging students whose education was disrupted over a two-year period; mental health issues manifesting themselves in families and communities. Our Annual Report 2022 demonstrates the extent to which we continue to maintain our commitment as an LCDC to local and community development in the face of emergent challenges.

The LCDC has a major oversight role in the disbursement of funding in South Dublin County. We do not take this responsibility lightly and strive to observe the best principles of good governance in all our decision-making. There was a significant increase in funding under the Community Enhancement Programme for 2022 and the introduction of additional funding through the Community Support Fund. The latter was aimed at community groups who required support in paying utility and rent bills, maintenance and upgrade costs and equipment. We worked diligently to ensure that we could deliver much needed supports to a wide range of community groups, and directed others to appropriate funding channels when we could not meet their needs. See Appendix 1 for details.

The LCDC is also responsible for creating the community dimension of the Local Economic and Community Plan. We are charged with developing a new plan which will come into force at the beginning of 2023. A steering group has been set up by South Dublin County Council to oversee the creation of the plan, and that group met several times in 2022. A number of consultations took place in 2022, and additional consultations will continue into 2023. We are determined that the new LECP will be relevant, grounded in community needs and socially inclusive.







South Dublin County Local Community Development Committee DRAFT Annual Report 2022 KPI 2 living in disadvantaged areas by Pobal HP Deprivation range






Breakdown of Individual (KPI 2) Interventions by support type:

SICAP Case Study for 2022

The SICAP Case Study on Preparing People for Employment & Promoting Better Quality, Sustainable Employment.

This Case Study outlines the targeted tailored supports provided by South Dublin County Partnership to help local communities and individuals to reach their full potential within strong and vibrant communities. The SICAP Programme has enabled a dedicated Employer Liaison Team who are very proactive across the County.

The SICAP Case Study Working Group comprises of representatives of the ILDN, LCDCs, the Dept. of Rural and Community Development and Pobal. The Working Group promotes the development of quality case studies to highlight good practice and innovation throughout the programme. The case study forms part of the End of Year reporting requirement. However, the value of case studies is recognised by all stakeholders through their widespread use by LDCs on their own websites and social media, by the Department, Pobal and ESF Managing Authority in their own annual reports including the SICAP Annual Report. The case studies are also used to provide valuable insight into the human stories behind the IRIS statistics when answering funder queries or parliamentary questions. In the past couple of years, they have formed the core material for coordinated social media campaigns #SicapStories and #Growing Communities to promote the work of SICAP in response to COVID 19 pandemic and the displacement of Ukrainian people because of the war with Russia.

The following is the Pobal feedback on the 2022 Case Study for Lot 3-1

The video case study is professionally presented and details how South Dublin County Partnership aims to assist those who have not benefited from economic and social development. The participants are the long-term unemployed and those facing barriers to employment, these participants are offered a range of targeted employment supports. The video details how SICAP enabled the South Dublin County Partnership to put in place a dedicated employer liaison team, it is evident that the team has developed an excellent relationship with a range of local employers. The employer liaison team matches programme participants to local employment opportunities as well as offering work placements and job shadowing opportunities. The employer partners play a vital role in facilitating mock interviews, providing industry briefings on their industry sector and participating in job fairs.

A number of their employer partners are interviewed in the video and share their experiences & the benefits of working with South Dublin County Partnership. There are several written testimonials from a range of other employers who recruited staff through the programme.

The outcomes of the programme are noted as increased income and financial stability for individuals and families.

Overall, this is an excellently presented video case study which clearly illustrates the benefits of their employer liaison team in tackling social and economic inequality. The support and services not only benefit the long-term unemployed but also many local employers through engagement with local job hunters.


6 | Local Economic and Community Plan

Local Economic and Community Plans (LECP) support the sustainable development of our counties. First described in *Putting People First: Action Plan for Effective Local Government* and then formalised in the Local Government Reform Act 2014, they form the local element of the national development framework and support collaboration to increase the quality of life in our communities. This has never been more important as we look to support a sustainable recovery from the impact of the pandemic.

The primary aim of the LECP is to set out, for a six-year period, the objectives and actions needed to promote and support the economic development and the local and community development of the relevant local authority area, both by the Local Authority directly and in partnership with other economic and community development stakeholders. The LECP is an important way to set out how Government and other stakeholders can work together to ensure that their initiatives, programmes and projects support an improved quality of life for people living and working in the county.

An LECP Advisory Group has been established to oversee the drafting and implementation of the new 6-year LECP for the County. Public Consultations began in 2022 with more to follow in 2023.

7 | LEADER Programme

LEADER covers the rural areas of South Dublin County (the electoral districts (EDs)) of Newcastle, Rathcoole, Saggart, Ballinascorney and Bohernabreena. Following the agreement between South Dublin County Council, Fingal County Council and Dún Laoghaire-Rathdown County Council, 5 members of the LCDC were selected to sit on the Rural Dublin Local Action Group for this round of LEADER Rural Development funding.

8 | LCDC Funding 2022

Social Inclusion Community Activity Programme (SICAP)

South Dublin County received an allocation of €2,451,324.00 in relation to SICAP in 2022. South Dublin County Partnership reports regularly to the LCDC. Details of the 2022 SICAP programme are outed in part 5.

Community Activities Fund under the Community Enhancement Programme

The Department of Rural and Community Development (DRCD) provided funding under Community Activities Fund (CAF), Community Enhancement Programme which supported community groups across Ireland.

South Dublin County Council was allocated funding in the sum of €338,797 during 2022 which was broken down as follows:

- €207,043 Current funding (non-Pay) for use towards running/operating costs
- €131,754 Capital funding for use towards carrying out necessary repairs and improvements to facilities, energy efficiency type projects, purchase of equipment etc.

Healthy Ireland Round 4 launched in 2022. The project is managed by South Dublin County Council in partnership with the HSE. A Healthy South Dublin County Co-ordinator commenced working on the 3-year Healthy Ireland Fund Local Strategy in October 2022.

Healthy Ireland is a government led initiative aimed at improving the health and wellbeing of everyone living in Ireland.

4 Key Goals

- 1. Increase the proportion of people who are healthy at all stages of life.
- 2. Reduce health inequalities.
- 3. Protect the public from threats to health and wellbeing.
- 4. Create an environment where every individual and sector of society can play their part in achieving a Healthy Ireland.


What is new for Health Ireland Fund (HIF) 2023 - 2025

10 | Sláintecare Healthy Communities (SHC)

Sláintecare Healthy Communities (SHC) is a multi-component interagency programme that is designed to meet the needs of a number of designated community areas across the country. It focusses on bringing about real, measurable change, based on an understanding of the determinants of health and evidence-based health and wellbeing programmes. Sláintecare Healthy Communities is led by Healthy Ireland in the Department of Health. The Department commissioned Local Authorities, the HSE and a wide range of community-based organisations to work together and deliver a range of health and wellbeing initiatives in targeted community areas and to integrate a health and wellbeing approach into the work of local authorities. Government funding of over €10 million has gone into the development and delivery of the overall programme.

Key messages about Sláintecare Healthy Communities:

- Partnership working across government, public services and interagency working at local level for community wellbeing.
- Addressing health inequalities by taking a targeted approach.
- All population health outcomes can be linked to people's social reality and lifestyle behaviours and SHC is working to address both.
- Evidenced based health and wellbeing programmes integrated with social determinants approach supported by local authorities.
- Enhancement Fund will enhance the community environment for health and wellbeing, examples include greenspaces, improved community facilities and walking and cycling tracks.
- Numerous HSE Health and Wellbeing components to be delivered locally such as Healthy Food Made Easy, Social Prescribing, We Can Quit, Community Food and Nutrition Worker, Making Every Contact Count.
- New staff working in collaboration to address Healthy Ireland where support is needed the most.

The LCDC received significant funding towards the initiation of a major Slaintecare Healthy Communities Project in South County Dublin. Funding has been provided for two CHO areas with the recruitment of 2 Sláintecare Local Development officers. The Local Development Officers work very much in partnership with SDCC's Community Development team, Healthy Ireland Coordinator, Sports Officers, Active Cities and Active Travel officers within SDCC to promote health and wellbeing in key areas of the county.

Significant funding of 500K from the Slaintecare Community Enhancement Scheme will be focused on improving outdoor amenities in areas of disadvantage has also been awarded with SDCC. Teams from public realm and community within SDCC will work to support development of improved amenities and outdoor recreation experiences in areas such as Balgaddy, Mac Uilliam and North Clondalkin in 2023.
