Dear Ms Sinclair,

I refer to your correspondence dated 15th December regarding a motion that was adopted at the November 2023 meeting of the Lucan, Palmerstown and North Clondalking Area Committee meeting regarding item number 81029.

Irish Rail recently announced changes and some additional services to their timetables, details of which are provided at the link below. However, as we haven't yet received confirmation of funding for 2024 from the Department of Transport, we are unable to outline what can be delivered in terms of additional services including services on the Dublin Heuston line. Please note that in recent months, a number of services between Newbridge and Grand Canal Dock (which serves all stations) at peak times now contain longer trains which has addressed some capacity issues.
