PART 8 SITE NOTICE**

Pursuant to the requirements of the above, South Dublin County Council hereby give notice to construct the following development in the Tymon area of Tallaght, including Castletymon Road, Castle Lawns, Castle Park, Main Road, Tymon Park and the surrounding areas in Dublin co. EirCode D24:

- Construction of 1 km walking and cycle facilities and traffic calming measures along Castletymon Road and in the Tymon area.
- Junction amendments to provide safer movement of pedestrians and cyclists
- Associated services
- Landscaping and Public Realm works

The proposal has undergone Appropriate Assessment Screening under the Habitats Directive (92/43/EEC) and screening for Environmental Impact Assessment under the EIA Directive 2011/92/EU, as amended by Directive 2014/52/EU. The authority has concluded that there is no real likelihood of significant effects on the environment arising from the proposed development and a determination has been made that an Environmental Impact Assessment Report (EIAR) is not required. The authority has also made a determination under Article 6(3) that the proposed development, either individually or in combination with other plans and projects, is not likely to have a significant effect on any European site(s). Any person may, within 4 weeks from the date of publication of this notice, apply to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.
