Dear Ms Sinclair,


I refer to your correspondence dated 2<sup>nd</sup> December 2024 regarding a motion that was passed at the Lucan, Palmerstown and North Clondalkin Area Committee meeting. I have attached your correspondence for ease of reference.

The Authority is working with the County Council and landowners to bring in a service along Shackleton Drive on route C2. This has not been introduced yet due to lack of a suitable road alignment onwards to the terminus at the rail station. A new proposal is being discussed with the landowner and we aim to progress it as quickly as possible.

For the longer-term we are working with the County Council to consider potential services related to development in the adjacent Clonburris area. While there are no plans presently for a new route along the R136 to Woodies, the suggestion is noted as part of this wider work.

I trust that the above is of assistance.
