About the Chief Executive's Report

It should be viewed in conjunction with the various updates provided to Area Committee Meetings as well as the quarterly Capital Progress Report to full Council as part of the reporting structures to assist the elected members with their governance and oversight responsibilities.

The report includes important updates and information from across our various directorates and departments together with a range of key statistics that were developed in conjunction with the elected members. "Think Twice – Think Bike" Motorcyclist Road Safety Campaign Launched

Our latest road safety initiative sees 2023. us partner with the Road Safety Authority, An Garda Síochána and neighbouring local authorities to launch the 'Think Twice, Think Bike' campaign.

This involves radio & social media campaigns to highlight to motor cyclists the dangers they face, particularly as summer approaches when more motorcyclists take to the roads.

It was launched at the May Bank Holiday weekend to encourage safer road use and to highlight 'safe ways' for motorcyclists to protect themselves. Motorcyclists are vulnerable road users with RSA data showing that 105 motorcyclists were fatally injured, and 921 were seriously injured between 2019 and

At the launch, our Road Safety Officer Orlaith Maguire said 'the campaign targets both motorcyclists and car drivers to focus on the safety of motorcycles on our roads. Research shows that almost 51% of fatalities occur at weekends and so far this year there have been 10 motor cyclist fatalities on Irish roads.

It takes a split second to change someone's life forever, and as a driver you have to ask yourself could you live with the consequence of your actions? We all share the road, so let's all come together to make that safer for motorcyclists and all road users."

This latest campaign follows three previous initiatives this year: safe

use of e-scooters, National Slowdown Day and National Tyre Safety Day and further details of each can be found at www.sdcc.ie

Safe Routes to School

Work continues by our Active Travel team to improve safety on main access routes to schools. Six schools in South Dublin County were included in Round 3 of the Safe Routes to Schools (SRTS) programme that was published by the NTA and An Taisce in 2024.

Travel surveys and front-of-school audits have been completed for four schools so far, and the remaining two will be completed this month. Once all audits are finished, we will prepare outline delivery plans for each school. These plans will recommend measures to improve safety at school gates and along main access routes, and we will begin progressing the design work later this year.

We have also provided additional funding for a supplementary Safe School Zones programme. This will see safety measures provided at further schools across the county, with front-of-school assessments and travel surveys conducted at eight schools and safety works proposed for four schools so far this year.

Monastery Road Wall Repair

In January Storm Eowyn caused significant damage around the county, notably at Monastery Road where an old mature tree fell causing major damage by knocking down six meters of stone wall at Monastery Rise.

We appointed Truir Construction to carry out specialist repair work to the wall, with craft stonemasons engaged to carry out the works.

As much of the original stone was used as possible along with traditional lime mortar and locally salvaged stone from our Corkagh Park depot to ensure that the repaired wall, which is now successfully completed, is in keeping with the original design





Tallaght LAP Extended

An extension to Tallaght Town Centre Local Area Plan (LAP) was approved at the council meeting in April meeting to align the LAP timeframes with the County Development Plan up to 2028. With the LAP originally set to lapse in 2026, the extension ensures a consistent policy framework for Tallaght. To date, under the LAP which was approved in 2020, there has been significant investment by the council, supported by the government's Urban Regeneration and Development Fund (URDF), to provide major public realm enhancements, an innovation centre and expansion of Tallaght Stadium along with the start of redevelopment of Cookstown and Airton, as the regeneration of Tallaght Town Centre progresses.

Launch of Affordable Homes at Canal Bank, Clonburris

60 new affordable homes at Canal Bank within the Clonburris Strategic Development Zone will be launched for sale later this month by SDCC.

These homes, ranging from one to four bedrooms in size, will be made available to eligible applicants under the Affordable Purchase Scheme.

Thie development at Canal Bank marks our first directly contracted delivery of affordable homes in many years, supporting increased affordable housing options under the national housing policy, Housing for All.

Canal Bank is a brand-new development of 116 social and affordable homes that is located adjacent to the Grand Canal near the heart of Clonburris. West Dublin's newest town.

It offers an excellent selection of highquality homes in a mix of houses, apartments and duplexes. Designed to feature parks, play areas, dedicated biodiversity areas, walkways and cycle paths, as well as new retail and commercial hubs, the new community of Clonburris will provide an urban living environment which will have new schools, community space, creches and which is also just minutes from Dublin city centre with Clonburris train station within easy walking distance.

The development is scheduled for completion by November of this year and so the 60 affordable purchase homes will be launched for sale in a single phase with the following home types available:

- 8 x one-bedroom apartments
- 18 x two-bedroom apartments

- 2 x two-bedroom houses
- 8 x three-bedroom houses
- 14 x three-bedroom duplex homes
- 10 x four-bedroom houses

These homes are being made available through the Local Authority Affordable Purchase Scheme, which helps eligible buyers bridge the gap between the maximum mortgage available to them and the market value of the home.

This involves a shared equity arrangement, reducing the upfront cost for purchases with SDCC retaining an equity stake in the property until that equity stake is repaid or the home is sold.

With support from the council and the Department of Housing, Local Government and Heritage through the Affordable Housing Fund, the prices for these homes will be announced in advance of the launch later this month.

Marketing of Canal Bank will be managed by DNG New Homes on behalf of the council and eligible buyers will be able to apply for these homes later this month.

The Journey, Directed by Newton Barabara

Nigerian theatre and filmmaker Newton Barabara collaborated with residents of the IPAS Centres-The Towers, Dolcain House, and the Red Cow Hotel – between January and April 2025. During the workshops, participants engaged in storytelling, role-play, acting, scriptwriting, and character development.

This programme builds on Barabara's earlier work at the Citywest Transition Hub, which concluded with a public performance of the play Halfway to Heaven in 2024. The

residency culminated in The Journey, a powerful original play that confronts the emotional aftermath of trauma and the urgent instinct to survive.

Set against the backdrop of displacement, the story explores how hardship tests human relationships, challenging trust, love, and identity. Through the harrowing path of its central character, we witness both heartbreak and resilience as they navigate fear, sacrifice, and fleeting moments of connection.

Newton Barabara aims for the play to stir deep reflection on the universal human experiences of loss, longing, and the pursuit of belonging. The Journey shines a light on the courage it takes to start over-and the unbreakable hope that carries us forward. Supported by the Arts Council and South Dublin

Cyber Awareness Week for Staff

As part of its ongoing commitment to digital safety, our IT Department hosted a series of Cyber Awareness events from 7th - 11th April. These sessions aimed to strengthen staff knowledge around cybersecurity and highlight the important role everyone plays in protecting the Council's digital systems. Over 170 staff members-including the Senior Management Team-took part in five informal coffee morning sessions. These engaging talks focused on key cyber risks and how staff can act as a "human firewall" to help prevent threats. Staff were reminded to report any suspicious activity promptly to ensure a fast and effective response. We look forward to continuing this important conversation during Cyber Month 2025, taking place this October.





Cardiff Council Workshop

The four Dublin local authorities recently held a workshop with Ffionn Gruffudd from Cardiff Council, joined by members of the Irish language community. The event included a panel discussion with community representatives, chaired by Kathy Scott from the Trailblazery.

Ffionn Gruffudd, representing Bilingual Cardiff, shared valuable insights on how Cardiff Council has worked to meet Welsh language standards. Given the similarities between the Irish and Welsh languages, the Welsh experience could help guide our own efforts to meet Irish language targets.

The workshop ended with a discussion on recruitment goals-looking at what lessons from Cardiff's approach apply to us, the challenges we may face, and the opportunities and actions we can focus on moving forward.



Burial Grounds Enhancements

Ongoing improvements are being provided to SDCC burial grounds to create more respectful and peaceful spaces for remembrance for families and visitors. These works include the development of columbarium walls, car park improvements and other enhancements.

Columbarium walls provide a suitable resting place within a cemetery for the placing of cremated remains with each columbarium wall divided into a number of niches which can each accommodate two urns of ashes and which have a front plaque provided allowing space names of the deceased to be engraved.

Such features are becoming an increasingly common and preferred resting place in many cemeteries, accompanied by a memorial garden

to offer a solemn and peaceful space for reflection.

We recently commenced development of a columbarium wall at Esker Cemetery in Lucan which is expected to be complete by the end of June following which it will be open to accept cremation burials soon thereafter.

A similar development is also due to begin at Bohernabreena Cemetery later in the year to expand the interment options there following provision in the council's budget this year to provide a columbarium wall there.

In addition, we will also shortly be upgrading the surfacing and linemarking in the car parks at both Bohernabreena and Newcastle cemeteries. These works are based on feedback from visitors who have requested these improvements to ensure a respectful and dignified experience at SDCC burial grounds.



our Waste Enforcement Team

Supporting Waste Enforcement

SDCC plays a key role in enforcing national waste laws through our waste enforcement officers who are authorised under the Waste Management Act 1996 and other environmental legislation, to monitor activities including construction debris. illegal dumping, waste metals, end-oflife vehicles, and the Deposit Return Scheme.

Last year our waste enforcement team conducted 3,348 inspections, handled 408 household waste complaints, inspected 98 sites, and ran 7 antidumping collection days, collecting 1,341 mattresses and 8,539 kg of hazardous liquids for recycling and disposal.

Local Engagement

In advance of the new library being delivered in Citywest, we have been building a local culture of learning and reading through increasing our mobile library service in the area.

Mobile libraries made 259 visits in 2024 alone, welcoming nearly 8,000 visitors to ensure an established and engaged user base from day one in the new library. In addition, we will undertake consultation to inform the final fit-out of the library to meet the needs and expectations of local residents.

library will serve as a vibrant hub for residents, students, and professionals in the area and construction is expected to start next month and will take up to 12 months to complete, fit-out and stock. Designed with sustainability and inclusivity in mind, the library will feature a dedicated children's section, study areas, public activity spaces, and a makerspace.

An outdoor terrace will provide a unique setting for quiet reading and



In addition, a revised planning application will be submitted this month by our project partners, Harcourt Developments, for the delivery of a start of the art and fully accessible new community centre and crèche at Cúil Dúin Avenue in Citywest.

Designed to NZEB energy efficiency standards the centre will feature flexible multi-purpose rooms, a community café, and an adjoining crèche while a landscaped forecourt will provide an inviting outdoor space. Subject to planning permission, construction will commence later this year with project completion expected in 24 months, followed by fit-out and occupancy of the centre. We are also progressing plans for a youth facility in Citywest Quarter which will involve upcoming consultation



to ensure that it meets local needs.

Alongside investment in community and learning, we are also enhancing recreational facilities with the phased upgrade of Carrigmore Park. The project includes an expanded playspace, a new teenspace, reinstated pitches, and a variety of sports and fitness amenities.

The newly upgraded playspace, featuring six new elements including a sandpit and rope swing, has already proven immensely popular with children. The teenspace, designed as a social and recreational area, includes a parkour unit, basket swings, hammocks, and a dedicated hangout zone while the planned pump track, calisthenics area, boules court, and enhanced landscaping will further enrich the park's offerings.

These projects reflect our commitment sustainable to community development and wellbeing to match the residential development in Citywest in recent years, ensuring that the area continues to grow as a dynamic and connected place.

Planning and Infrastructure

Progress on the County Development Plan included approval for over 12,000 new homes, with 5,475 completed since 2022. Sustainable mobility was prioritised with upgrades to roads, bridges, pedestrian crossings, and school zones. Maior enhancements to public spaces took place in Lucan, Tallaght, and Dodsboro.

Equality and Integration

South Dublin County Council's 2024 Annual Report reflects a year of achievement, innovation, and community engagement, marking 30 years of service since its establishment in 1994.

With a growing population of over 300,000 and a strong commitment to inclusivity and sustainability, the Council delivered on key targets across housing, climate action, economic development, and community wellbeing.

Housing and Community

A record 774 new social homes were delivered, alongside 210 long-term leases and 55 affordable homes. Projects progressed in Clonburris, Kilcarbery, and Belgard, while efforts to reduce homelessness saw 1,245 housing allocations, including 267 for homeless households. Community facilities were developed in areas such as Saggart and Glenasmole, and €2.2 million was allocated under the Community Recognition Fund

to support integration and supported by developments local engagement.

Climate Action and Environment

Under the Climate Action Plan, energy efficiency improved by 45.5% since 2018, with 43% fewer emissions. Initiatives included the retrofitting of 85 homes, 1,690 LED streetlight upgrades, and 22.5 km of new cycle lanes. The Clondalkin Decarbonising Zone and €1.1 million in Community Climate Action funding supported meaningful local change.
