Changes to the 2006 Student Maintenance Grant Schemes

A. Changes Common to all 4 Student Maintenance Grant Schemes: -

1. Reckonable Income limits

- 5.3% increase in income limits in respect of "Ordinary" rates of maintenance grant;
- 7.18% increase in income limits in respect of Special "Top-up" rate of maintenance grant.

2. Rates of Grant

- 3% increase in "Ordinary" rates of maintenance grant;
- 22.5% increase in "Top-up" element of special rate of maintenance grant.

3. Definitions:

The definition on the Student Services Charge has been amended to reflect the existing wording of Clause 5.4. of the HEG and VEC scheme

"student services charge" means the charge payable by students pursuing an approved course to which the Free Fees Initiative applies in an approved university or third-level institution in Ireland. This charge relates to examination fees, registration and student services.

An addition to Clause 1 of the HEG, VEC and TLT schemes is the following reference to Field Trips.

"field trip" means a trip which is compulsory and an integral part of an approved course, which is for fact finding or research purposes, and without which the student cannot graduate or progress to the next year of the course.
