At the October meeting of Monaghan County Council, the members passed the following resolution, and I was directed to forward same to you for attention:

*'That this Council condemns all those involved in the neglect, mistreatment and abuse of residences in Nursing Homes and Care Facilities for the elderly, the most vulnerable in our society and demands of An Taoiseach, Micheal Martin T.D, the Minister for Health, Jennifer Carroll MacNeill T.D. and all of Government to immediately prioritise the strengthening of safe guarding protection across the Health and Social Care Sector, as national confidence, trust and respect for the Health Information and Quality Authority(HIQA), the HSE and the Department of Health is very low, following the revelations of recent years - Children's Health Ireland(CHI), the numbers of deaths during Covid proved standards were very low in Nursing Homes nationally, the recent RTE Undercover Report exposed the abuse of residences in Nursing Homes and were it not for this programme, the nation would be unaware of these outrageous incidents; hence Monaghan County Council demands of all members, parties and groups in Government to act immediately to ensure the Health and Social Care Sector in Ireland is cleansed of neglect, abuse and wrong doing'.*
