"Is there an update on the plans for a community garden/sensory area in the park next to Jobstown community centre?"

REPLY:

The playground beside Jobstown Community Centre was inspected by an independent ROSPA-certified playground inspector, who found the equipment to be unfit for purpose due to extensive vandalism. Despite being secured, the site continues to attract antisocial behaviour, with individuals forcing entry and congregating there.

The Council intends to decommission the existing playground and reinstate the area as an open green space, as new and enhanced playgrounds have already been delivered in Jobstown Park, Killinarden Park, Whitestown Stream Park, and Kiltalown Park. Once

reinstated, the area will remain available for future consideration, should an appropriate project and budget be identified and agreed in collaboration with relevant stakeholders.

"Can the Manager arrange a clean-up around Kiltalown lane as the area is a dumping ground for fly tipping?"

REPLY:

Kiltalown Lane was inspected and cleaned by Public Realm staff on 25/10/25. Having recently had additional public lighting installed along with some boundary treatment to deter the repeated fly tipping incidents, our colleagues in Waste Enforcement recently installed a temporary CCTV system at 3 locations on Kiltalown Lane. The CCTV was installed in line with the LGMA's Code of Practice. During the installation, three (3) incidences of dumping were recorded and these are now the subject of enforcement actions. SDCC proposes to reintroduce temporary CCTV at further locations along Kiltalown Lane.

South Dublin County Council's Tallaght 2023–2025 Tree Maintenance Programme includes 43 estates and roads, with Ashfield and Ashgrove estates remaining outstanding. "To prioritise high sensory equipment in the parks, i.e. trampolines, resistance activities, visual and sensory equipment to accommodate children with high needs?"

REPORT:

South Dublin County Council welcomes the motion to enhance sensory play provision in our parks. SDCC is recognised as a leader in the design and delivery of inclusive and natural play spaces, both nationally and across the European Union. In recognition of

this work, South Dublin County Council received a Special Mention in the 2023 EU Access City Awards for its innovative approach to accessible landscapes and play areas — highlighting the Council's success in creating environments that are inclusive, imaginative, and connected to nature.

Over the past decade, the Council has developed more than forty new and refurbished play spaces that apply the principles of Universal Design and natural play, ensuring that children of all abilities can play together in shared environments. These play spaces already incorporate a rich variety of sensory experiences, including trampolines and play features that involve climbing, spinning, rocking, and balancing, all set within natural surroundings to provide high-value sensory and physical experiences for children.

While sensory and accessible equipment plays an important role, best practice emphasises the importance of prioritising the overall play environment rather than focusing solely on equipment. The Council's approach therefore considers the landscape form, planting, natural materials, and layout as integral to inclusive and engaging play design, with equipment forming one component within a universally accessible and stimulating setting.

The Council's universal design approach does not prioritise one group of children, such as those with higher needs, over others. Instead, SDCC recognises that children have a broad range of needs, abilities, and ways of engaging with play, and seeks to create environments that allow everyone, regardless of ability to play together. This inclusive and integrated model is regarded as best practice across the EU and continues to shape all new play developments within the County.

The Council has also recently adopted a new Play Policy: The Nature of Play, which reaffirms its commitment to inclusive and accessible play provision. The objectives and actions set out in this policy will guide the future design and delivery of play spaces, ensuring that these commitments remain central to all ongoing and upcoming projects. The chapter on Accessibility includes information on both equipment and natural features incorporated into play spaces to improve accessibility.

Finally, the Council places a high value on feedback from children, families, and community members, and encourages residents to participate in local play consultations. This feedback is used when setting the design briefs for individual play areas ensuring that the specific needs and aspirations of each community are reflected in the final design. The Council therefore actively encourages participation in these consultations, as community input is central to delivering play spaces that are inclusive, well-used, and that meet specific local needs.

"That the Manager report on current fines for dumping in the Tallaght area?"

REPLY:

All incidents of illegal dumping reported or detected in any area are investigated by the Council's Litter Warden Service and all dumped material is searched for evidence. Where evidence is found, the appropriate enforcement action is taken under the Litter Pollution Act 1997, as amended.

Increasingly, it is found that no personal information relating to polluters is contained within the dumped material, with personal information having been removed or shredded.

The Environmental Complaints System operated by South Dublin County Council provides a statistical breakdown by designated litter warden areas. The total number of complaints made under the Litter Pollution Act 1997 and investigated by the Litter Warden service for 2025 to date is 1,506. This figure includes 837 investigations that were specifically for litter investigations only.

"This Tallaght area committee call on SDCC to plan for 2026 Halloween in the lines of a festival bonfire and localised entertainment highlighting and keeping the culture of the Halloween festival at the forefront?"

REPORT:

Halloween dates back over 2,000 years to the ancient Celtic festival of Samhain, which featured harvest festivals and otherwordly storytelling. SDCC's Samhain and Halloween events held across the County embrace a unique blend of these ancient customs with modern celebrations. These creative and fun events for all the family include the likes of costumes swaps and creepy crafts, silent discos, spooky science, and Storytime

sessions across SDCC Libraries. Samhain in South Dublin includes Halloween walking tours in Tallaght in English agus as Gaeilge, a Halloween Walkway at Brú Chrónáin Round Tower Visitor Centre as well as main events at Partalán Place (Tallaween 11am – 5pm, 31st October) and at Brú Chrónáin (Spookdalkin 11am – 4pm 2nd November). Community Services actively assist a number of small local community based Halloween celebrations, organised by community groups/centre across the County.

Whilst Halloween is a time of celebration regrettably it can also be a time of environmental and property damage. This has a significant impact on resources available to South Dublin County Council for the provision of facilities and amenities within the county. As with previous years, the Council is prioritising a safe Halloween in 2025, in an effort to reduce injury to individuals and damage to property and the environment.

Large bonfires present significant fire safety hazards, especially in residential and urban areas. Evolving climate and environmental conditions make open fires increasingly risky and difficult to insure. Managing crowd safety and ensuring adequate emergency access for a nighttime outdoor event presents additional logistical challenges, particularly given that Halloween is the busiest night of the year for Dublin Fire Brigade. Bonfires also conflict with sustainability goals due to emissions, debris, and potential damage to green spaces.

In response to the above, and in addition to an exciting programme of local events, SDCC operates 'Bulbs not Bonfires' a reward provided through the social credits scheme which provides communities with flowers in the spring instead fire damage throughout the year, whilst SDCC and WEEE Ireland is offering free electrical recycling for residents' associations and estates in South Dublin before and during Halloween 2025.

SDCC will continue to work into 2026 to develop fun, creative, and family friendly events for the whole community, championing the spirit of Samhain. Details of the above events can be found on www.sdcc.ie, or the Council's social media channels.

Housing

"Can the Manager report on how many vacant social houses in Tallaght area and how long that they are vacant?"

REPLY:

Our Housing Maintenance and Refurbishment section undertake re-let works on vacant housing stock throughout the County to ensure stock is brought back into productive use for letting as soon as possible. The current turnaround time from the date a property is surrendered to the date it is allocated is 23.85 weeks.

There are currently 26 vacant homes in Tallaght within our housing stock which are at various stages of the re-letting process as follows:

"Can the Manager report on how long is talking for repairs of heating in council houses in the Tallaght area and make this a priority for the winter months when tenants have a breakdown of heating?"

REPLY:

The Council categorises all requests for repairs depending on the nature of the problem. Repairs to heating systems are classified as an urgent repair by our housing maintenance team with a completion target within 10 working days from the date of the maintenance request. Our mechanical contractors respond to all reported heating system faults as soon as possible with further priority being given to older and vulnerable tenants where needed. The majority of repairs are completed during the first visit, however, follow-up visits may be required due to availability of parts, the severity of the fault or other such unavoidable issues.

To date in 2025, a total of 2,327 work orders were completed in the Tallaght electoral area in response to problems reported with heating systems. The average number of days for completion of these works was 4.7 days.

"How many current expressions of interest have been submitted for private homes in Tallaght looking to avail of the right sizing scheme through SDCC?"

REPLY:

The council's rightsizing policy provides for the allocation of age friendly homes to people aged 55 or older through the housing list, transfers (existing tenants rightsizing) or the community list (financial contribution for private homeowners rightsizing). It is intended that 50% of homes in new age friendly housing developments will be used for rightsizing, with priority for tenants transferring from local areas, and one in five rightsizing opportunities will be available to private homeowners through the community list. For inclusion on the community list, the homeowner must agree that the council will either purchase their existing home at a discount or accept a financial contribution from the net proceeds of the sale of the property depending on the homeowner's age.

60 expressions of interest were submitted by private households in the Tallaght area for SDCC's Rightsizing Scheme.

"What measures are to be taken as a matter of urgency to ensure that the development (planning application SD23A/0237) complies with the local area plan objectives for CTF1? I refer to your answer to my question on the uncovering of the River Poddle in Tallaght - ITEM ID: 88220. In the Local Area Plan, areas CTF1 and CTF2 are targeted for exploring the uncovering of the River Poddle. However, a new development has been granted planning permission in CTF1 on the basis of the River Poddle being referred to as a "surface water pipe/sewer/drain" (planning application SD23A/0237). It indicates that the river was not considered in the plans at all, let alone its uncovering?"

REPLY:

The Tallaght Town Centre Local Area Plan 2020 is a strategic framework for the sustainable development of Tallaght Town Centre. One of the many objectives of the plan is to "explore the feasibility of uplifting the River Poddle and incorporating into

public realm, open space and green/blue infrastructure asset strategies as part of proposals for development". The objective TC15 is specific for the development of the area the plan defines as "the Centre". More specific, the objective relates to a parcel of land adjacent to the northern and eastern boundary of the Work IQ Innovation Quarter, where the source of the River Poddle is located.

As per the Local Area Plan, the delivery of the objectives will be subject to the planning and development of sites and is reviewed on a case-by-case basis and where relevant. A number of factors are generally considered when proposing to uplift a section of river and as stated in the Tallaght Local Area Plan, they must be feasible. Some key considerations may relate to flood risk and potential risks and implications of uplift, ability to connect and link to high quality public open space, scale and quality of specific section of river and its proximity to rights of way and accesses, public transport and road networks. It should be noted that all proposed development sites that form planning applications are considered in accordance with the objectives of the Local Area Plan

REPLY:

It is noted that the Question relates to the Potential Temporary Site Compounds identified adjacent to Birchview Avenue and Bancroft Park as per the approved Preliminary Design Drawings for the Tallaght / Clondalkin to City Centre Core Bus Corridor Scheme (CBCS). The NTA have advised that, to date, neither site has been acquired by way of CPO, license agreement or otherwise and that both sites are currently being reviewed for suitability. Regarding timeframe for construction of the Tallaght / Clondalkin to City Centre CBCS, the NTA have advised that the programme for such is currently under review and the exact date for commencement of construction is yet to be confirmed.
