HI – November 2025 Minutes

H2– Planning & Development Act 2024

The report as circulated was presented by Mr P Collins, Senior Exec Planner.

The report focused on:

H3 – Revised National Planning Framework Update

The report as circulated and presented by Ms Hazel Craigie, Senior Planner.
