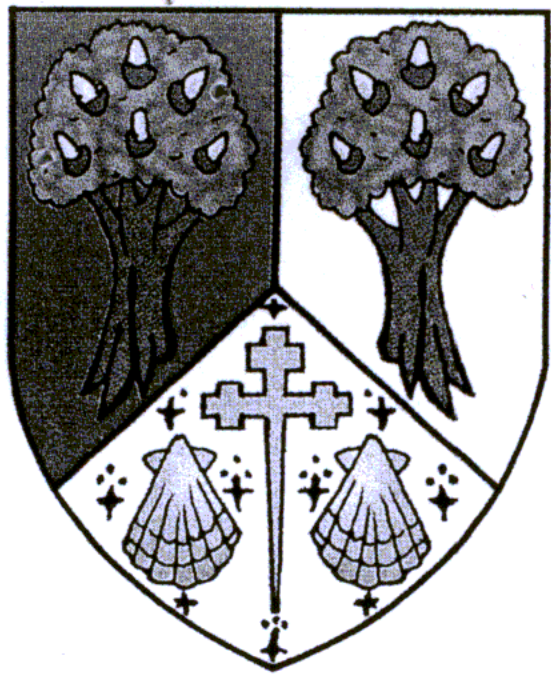

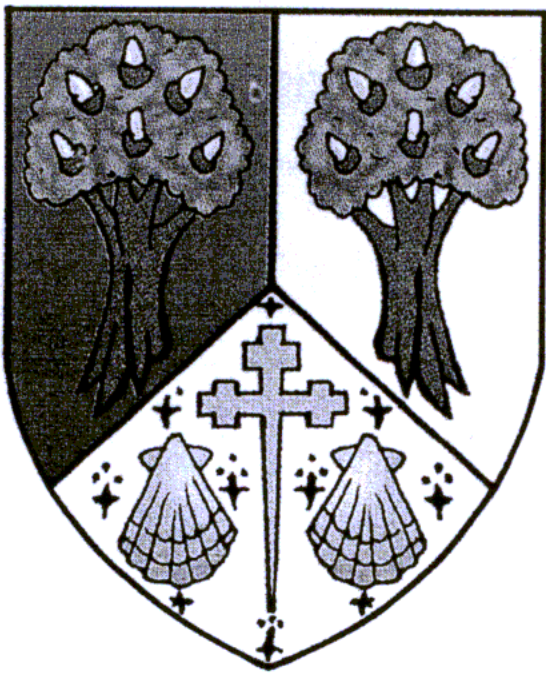

A Chara,

I wish to advise that the Elected Members of Edenderry Town Council at their monthly meeting held on 12th July, 2006, supported the proposal that the Government should be encouraging 'educational motoring.'

The concept would involve setting up 'training areas' for learner drivers in order that they can experience in a controlled atmosphere, road hazards such as potholes, a slippery surface or fog. The proposal was put forward as one suggestion in bringing about a reduction in the unacceptable number of road deaths.
